veys and that the dotted red lines on
said sketch truly and correctly represent
connecting lines actually run by me
on the ground between the points as
indicated -

I further certify that in making said
surveys and sketch I have placed the
V. Flores and M. C. F. Fossius surveys by
the Spring branch and bends of the
Demard river as called for in their
respective field notes - it being impossible
to find any of the bearing trees called
for in their said field notes - or the mouth
of any muddy branch of said river as
called for in said Flores survey - and
the said Spring branch and the bends of
the river as it originally run exactly fitting
the calls for them in both said Fossius &

Flores Survey^s. and I further certify
that the dotted blue line shows the true and
correct position on the ground of steep bluff
banks against which the river ran at one
time and that there is no other bend of
said river or spring branch running into
same that would satisfy the calls for the
same in said Flores and Frissins surveys.
