Report of a Survey showing the location of Survey No. 364, J. Poitevent Cert. No. 1/371 according to a survey made by me on the ground November 6th, 1936.

I began at the Original NW Cor of Sur No. 359, J. Poitevent Cert. No. 1/370, the NE Cor of Sur No. 361, the SE Cor of Sur No. 363 and the SW Cor of Sur No. 362, where I set a Square Headed Iron Bolt from which an old Mesquite Mkd // on the SW side brs N 76° E 19 vrs (Found) and an old Mesquite Mkd // on the NW side brs S 28°-30' E 12 vrs (Found) both trees are the original bearing trees for this corner, and from said Bolt the West Point of Charamusco Hill brs S 76°-30' W, the Peak of Camel Hill brs N 40°-58'E and the West Point of Hill on Horizon brs N 10°-47' W;

THENCE, with the South line of said Survey No. 363, West at 1373.4 vrs cross the center of Ygnacia Creek, at 1856.65 vrs top of small hill between two hills at 1900.8 vrs no corner found and no original bearing trees could be found, at 1906.46 vrs set a 4"x4" Conc. Monument Mkd SW 363 on the West slope of the said small Hill, (near this point was found the remains of an old Mesquite Stake Mkd //) for the SW Cor of Sur No. 363 and the SE Cor of Sur No. 364 from which a Forked Mesquite Mkd /x// brs N 65°-31' W 155.7 vrs and a Forked Pita brs N 72°-25' W 11.6 vrs;

THENCE North at 1900 vrs found no original corner, this point being 749.82 vrs west of the center of Ygnacia Creek, at 1919.38 vrs a point from which a stone set by others brs West 12.22 vrs at 1928.99 vrs set a 4"x4" Conc Monument Mkd NW 363 for the NW Cor of Sur No 363 and the NE Cor of Sur No. 364, this point being 740 vrs West of the center of Ygnacia Creek, at 2900.96 vrs cross Ygnacia Creek 3836.96 vrs to a large rock set by others for the NW Cor of Sur No. 95, the NE Cor of Sur No 97, the SE Cor of Sur No 99 and the SW Cor of Sur No. 100 (no original bearing trees could be found) the said Rock being 680 vrs S 89°-32' E from the center of Ygnacia Creek and is recognized as the NW Cor of Sur No. 95;

THENCE Back to the Conc Monument Mkd SW 363 by me;
THENCE West at 17.79 vrs a point 2.00 vrs South of a Stone in Stone Mound recently set by others, (this stone is on the west edge of a small ravine and is too far under the hill to have been the location of the original corner of Sur No 364, it would have been impossible to have seen any Hackberry on the bank of Ygnacia from this position.) at 1917.5 vrs set a 4"x4" Conc Monument Mkd SW 364 for the SW Cor of Sur No 364. (no original cor found)4

THENCE South at 250.19 vrs found an old stone Mound on point of Hill, at 1232 vrs center of Creek at 1460 vrs old road at 1530 vrs center of creek in Hackberry Mott at 1844.95 vrs set stake from which an old Three Prong Mesquite Tree brs S 4°-00' W 66 vrs, N. point of hill brs S 81° W and Devil's Hill brs N 14°-30' W;

Back to Conc Monument Mkd SW 364 by Me;
THENCE North at 1928.99 vrs set a 4"x4" Conc Monument Mkd NW 364 (no original corner found) from which I marked a Mesquite L bearing N 89°-23' E 39.5 vrs and a Mesquite V bearing N 42°-04' W 38.75 vrs, at 3857.98 vrs found a Stone in Stone Mound from which Devil's Hill brs S 18° W, (no bearing trees could be found) this is the recognized SE Cor of Sur No. 367 and the NW Cor of Sur No. 97 from which a Stone 2ft high Mkd H, on top of Hill brs N 89°-23' W 1917.5 vrs, from which Devil's Hill brs S 23°-23' E, this is the recognized SW Cor of Sur No 367 and the NW Cor of Sur No. 98.

Variation to re-run John J. Dix Surveys in this area : 11° - 03' E
