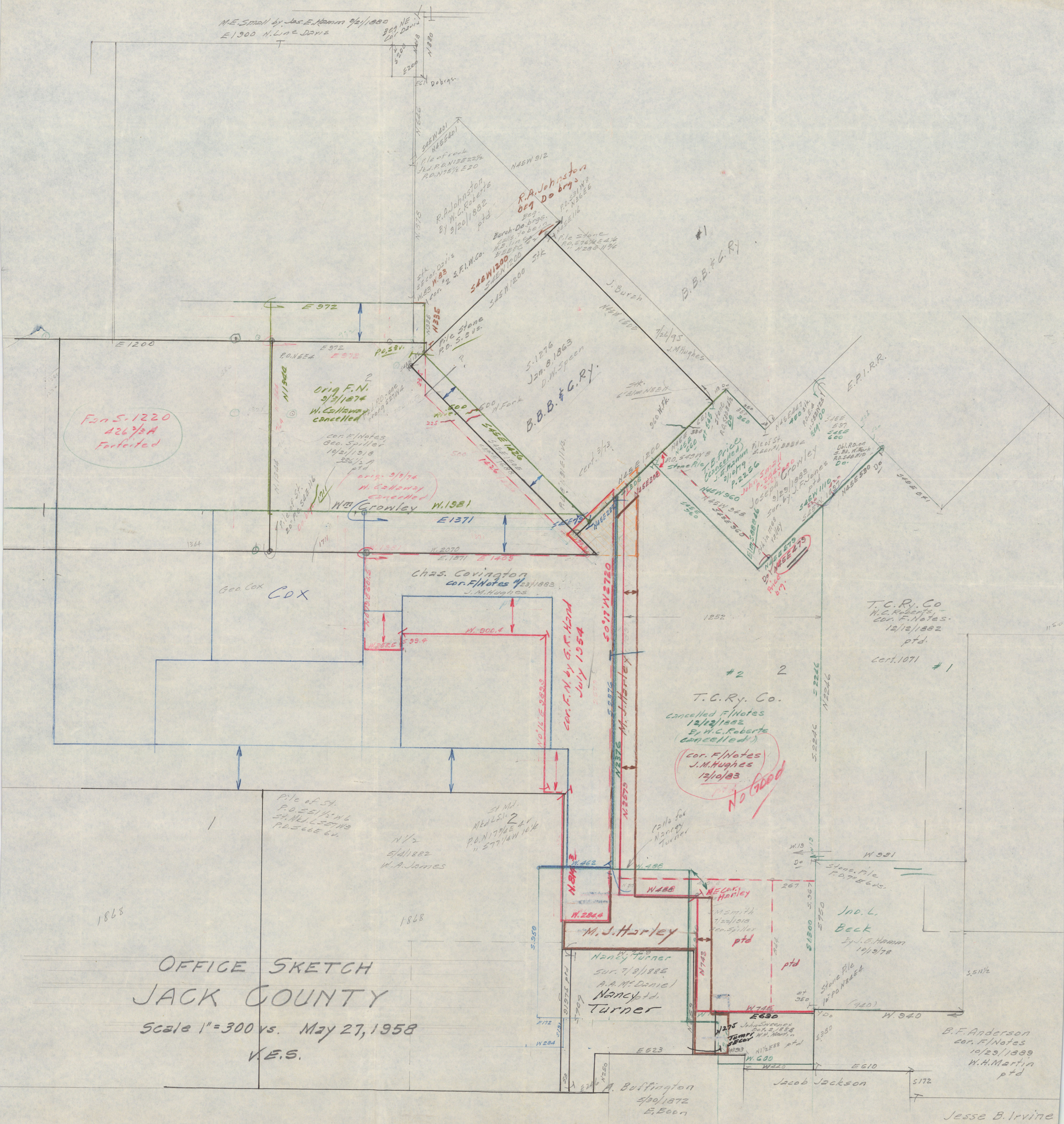
The surveyor has never conclusively shown the relation between the beginning corner of the Charles Covington Survey, which is the NE corner of the George Cox, and the SE and SW boundary lines of the BBB&C RY. CO. There were several different field notes filed on the Covington, the T. C. RY. CO. Survey 2 and the William Crowley - these field notes all reflect discrepancies in their location of the BBB&C RY. CO. Survey.

The records on file in this office indicate considerable confusion and conflict in the surveys adjoining the BBB&C RY. CO. Survey and, unless a surveyor can properly locate the original position of the BBB&C RY. CO. and then construct the South line of the Crowley and the North line of the Charles Covington from the original NE corner of the George Cox, it is impossible to determine the true positions of the respective surveys.

According to the construction as reflected by the office sketch May 27, 1958, a copy of which is attached hereto, and not having benefit of the required surveying data, the only conclusion that can be reached concerning the area described in the application of Mr. H. E. Conway (SF-15978) is that a vacancy does not exist and that the area in question is out of the Charles Covington Survey.
