The# State of Texas, # Field notes of connecting lines, in King county, county of King. # Texas. Var N. 10° E. May 18th. 1902.

Beginning at N. W. corner of survey No. 61 and N. E. corner of sur. No. 60 of Block A, made for J. B. Rector, whence a bolling spring in the bed of Middle Wichita River brs. N. 38 W. 43 vrs. and anoths spring or branch comming outs from under the hill between it and the river brs. S. 20 E. about 300 vrs. See field notes of section No. 61. Thence east at 141 1/2 vrs. cross Middle Wichita at 160 vrs. on high bluff of same at 485 re-cross river, at 1240 vrs. upon point of ridge at 1420 vrs. pass fN side of round mound about 50 feet high, at 1942 vrs. a point 25 vrs. N. of corner, xma an old stone mound, about 150 vrs. from base of ridge whence round mound brs. W. 520 vrs. Thence North at 1720 vrs. cross Middle Fork at 2100 vrs. cros it again, at 2520 vrs. cross it the third time, at 4750 vrs. (2 1/2 miles) a point on North side of branch, thence east at 950 vrs. a point on east E. slope of ridge, whence a stone mound made for the S. W. cor of survey No. 47 brs. N. 13 W. 247 vrs. This mound of stone was made by Mr. Moore 1900 vrs. west of a stone mound made by Mr. Goodfellow for the N. W. cor. of survey No. 43.

Note: There are no indications of the original work of 56, 55 and 57 west of this point, nothing on this line going west as described in field notes. I did not run the line directly west from this point, but ran one parellel to it 500 vrs. south.

Thence south# 45 East 335 vrs. Thence south 118 vrs. a stone mound of three stones, one set and marked S. Which we supposed to be the S. W. cor. at 47 A. B. & M. no bearings N. 22 1/2 W.

May 20th. 1902. Beginning at a Yournigen spring, or rather between two springs 2 vrs. #apart on N. bank of a branch about 150 vrs. east of where the old military trail crosses the Wichita river. Thence south at 160 vrs. cross the said trail at 300 vrs. another spring branch, at 478 vrs. an old stone mound about 100 vrs. S. W. of trail, course N. 30 W. There are numerous Hackberry and Mesquite trees around, some of them old. This is the cor-ner from which J. H. Glasgow says he made his connections to block A. and the one adopted by Mr. Goodfellow for S. W. corner of survey No. 43, A. E. &. M. From this# stone mound we ran south 45 east 2 660 vrs. and south 162 vrs. and west 8 vrs. to a stone mound, one stone set in ground, the old P. 8 ranch brs. East about #1/2# mile. Thence north at 460 vrs. we are in a small wash, no spring, at 780 vrs. pass 20 vrs. east of the head of spring branch, at 1460 vrs. to spring #branch, at 1480 vrs. crossed it, plenty of water in this very dry time, at 1948 vrs. a stone mound, one s tone set in ground and marked S, whence a bunch of Mesq. brs. S. 18 east 25 vrs. The centre one is dead and is the parent tree, was an upright tree and was blazed upon its N. W. side, but the X in now gone. The creek brs. West 260 vrs. I see no reason for the discrepancy between this call and the call for a spring going south, except that the spring should have been called for 1440 vrs. N, of the southwest corner, instead of that 1440 vrs. south of the N. W. corner. One thing is perfectly plain, that this is the N. W. corner of No. 43 as further developements will show. Mr. Goodfellow's corner can be seen across the creek N. 43 W. Thence west at 260 vrs. in bed of creek (Middle Wichita) at 466 vrs. a point whence stone mound brs. N. 499 vrs. I examined this stone mound, having noticed in Mr. Goodfellow's field notes that he enlarged it. I could recognize the newly placed stone by the portion of each that had lain in or upon the ground. On going to the bottoment I found a large flat stone, say, 18 X 18 inches, and a piece of same about 8 X 6 lying upon it, and underneath the small stone the large stone had a red spot the size of the small stone. The remainder of large stones wass white, which showed it had been long exposed to the weather. A large Sypsum stone also laid upon the large flat stone, but it did not show to have been recently dug up and supposed it must have been laying xix beside the flat stone. Continuing west from point at 466 vrs. at 1905 vrs. a point, whence a stone set in the ground brs.

S. 45 W. 50 vrs. from which a Hackberry tree standing alone brs. N. 22 1/2 W. 148 vrs. (Var. 11°) and analar another tree stands about 12 milas vrs. to S. W. which answers very correctly to the call in field notes of No. 57 for a H. B. N. 27 1/2 W. 150 . Beginning at stone set for S. W. cor. No. 47 A. B. & M. whence a Hackberry tree brs. N. 22 1/2 W. 148 and do brs. about N. 27 1/2 W. 140 vrs. Thence west (changed var. to 110) at 225 vrs. passed the stone marked S. at 1780 vrs. base of hill at 2155 vrs. a stone MAX Md. at base of another lower hill and cedar stump, top recently fallen down, but for a long time dead, brs. N. 15 1/2 E. 25 vrs. Thence west at 800 vrs. E. base of hill extending to the north at 1300 vrs. we crossed dry creek at grove of Mackberry trees (See field notes survey No. 55) at 1920 vrs. a point, whence a round mound or peak (60 ft. high) brs. west and and mound brs. N. 14 E. built of small cobble stones. This point catches the east end of the m'd bearing N. 14 E., but I judge that the original surveyor was 20 or 25 vrs. further west. Thence west at 940 vrs. passed over a dam about 10 vrs. north of the west one of two windmills, at 1015 vrs. base of hill about 40 vrs. south of old dugout at 1900 vrs. (measured this fine twice) built a stone mound about 2 feet each way, whence we marked a leaning mesquite tree mkd. X brs. N. 85 3/4 W. 25 2/5 vrs. another leaning mesquite tree mkd. X brs. N. 77 1/4 W. 26 vrs. one rock in md. mkd N. W. 56. Thence west at 776 vrs. on side of round peak at 845 vrs. passed 1/2 vrs. North of large pile of stone on top of said peak at 950 vrs. on ledge at maxim south base at 1440 vrs. branch at 1500 vrs. grove of Hackberry trees at 1940 vrs. cross branch at 2783 vrs. crossed a N. & S. wire fence at 2850 vrs. made small pile of stone for trial N. W. cor of No. 162 Blk. A, a double Hackberry on prarie brs. west about 150 vrs. and grove of Hackberrres brs. S. 35 E. Thence north at 1474 vrs. passed 1 vr. east of a very old stone md. one stone mkd. X. at 1900 vrs. left reference for xxxx trial corner for N. W. cor. 163 Blk. A. (Further developements showed these corners to bes further west if run from N. W. corner of survey No. 59 Blk A.)

Hay 22nd. Beginning at the S. W. cor. of thef J. Burleson survey a star stone md on prarie near futhrie and Paducah road. Thence east var. N. 9 46' East crossing Paducah road within 200 vrs. at 1038 vrs. crossed a skank branch at 1415 vrs. on prarie, at 2460 vrs. in branch. at 3974 2/5 vrs. to stone mkd. J. H. as described in field notes of J. W. Massie No. 1. Thence fast at 1900 vrs. a stone at cor. of fence where two stones are set, at 1900 vrs. Bois 'd arc post. Thence east at 1885 vrs. passed stone set in ground at 1900 vrs. a post set in ground 1 1/2 vrs. south of fence ling, at 3785 vrs. pass a stone on N. side of fence line, at 3800 vrs. a point 3 vrs. south of North end of fence line. Thence north at 1900 vrs. a point 3 vrs. south of North end of fence line. Thence a stone lying on ground brs. S, 20 vrs. and from it a young Hackberry brs. south 19 1/2 west about 60 vrs. Thence east at 1860 vrs. a pt. whence a stone lying on ground brs. S, 20 vrs. at 3788 vrs. a md. of stone at corner of fence, at about 4000 vrs. we found grove of Wild Chinas to our right about 100 vrs. No marks, at 5700 vrs. a large pile of stone built by Mr. Goodfellow for N. E. cor. of sur. No. 11 D. & W. R. K. Co. I accept this corner as correct. Thence south at 628 vrs. a point whence **6 tried point fregerance** for N. W. cor No. 163 brs. West 43 vrs. Thence **6 tried point fregerance** for N. W. cor No. 165 brs. West 43 vrs. May 24th. Beginning at stone md. on round peak 845 vrs. west of N. W. cor. of survey No. 56, & B. & M., whence a monuments of rock built square and perpendicular brs. N. 34 E. about 200 vrs. and Hayrick mountain brs. S. 46 1/4 E. Thence south var. 9° 41' E. at 2690 vrs. on oblong flat top mountain, whence Hayrick mountain brs. N. 84 E., at 3800 vrs. Hayrick Mt. brs. North 45 E., at 4220 vrs. a point looked for N. W. 59 Blk. A., at 4400 vrs. points. Thence west 237 vrs. a large stone mound, whence Hayrick mountain brs. N. 39° E. CharM. Cor. said 59.

Beginning at S. W. survey No. 43, A. B. & M. a stone md. Thence south at 1300 vrs. in branch, measured west 466 vrs. and found no stone md. gave considerable search, continuing south at 1920 vrs. I found a dilapidated stone md., two stones with smaller stones between them and larger stone 12 X 12 on ground. I believe it to be the stone md. called for in field notes of survey No. 42 A. B. & M., but I could not verify it in any way. I ran no further lines, but was taken to a stone md. located north of the stone at S. W. cor of 47 and west of it I likewise found a stone mkd S. Mr. McCaughey says these stones mkd S. were put up in about the year 1384. The south line of No. 47 being 255 vrs. excessive I supposed they were# put in course and distance from the north west cor of survey No. 57 which had until recently been easily identified, but now the bearing tree has fallen down. I respectfully submit to the Honorable Commissioner-these investigations, feeling sure that any fair minded surveyor will find them just as I have described them. I feel sure that the Honorable J. J. Goodfellow will likewise find them as I did. As to the stone md. near where he makes a cor. of 165 I find other stone mounds over the Block in different places. I am told by Mr. W. A. Jones that he built many corners in Block A. as he surveyed all this land for J. C. Eustice in about the same year J. H. Glasgow made the survey for Thompson and Rector.
