Dear Sir:-

I herewith enclose a sketch of some surveying I have done in Starr County. Mr. R.E. Margo, the present owner of Survey No. 340, wishes to obtain a patent on same, but there is a great error on its lines and I cannot decide on how to correct same. You will notice on the sketch a fence line marked "Sanchez present fence". This fence line was surveyed off by George Lund, the Ex-County surveyor of this county, and the present owner of survey No. 343, Sanchez Brothers, set their fence on the line given them by the County surveyor, and this has been over ten years. You will notice another line marked "old fence of Munoz's". This is an old wood fence, now down, but originally built by Luciano Muñoz, the patentee of Survey No. 343 and on its north end is an old hewed mesq. post marked "340-N.E.", as called for in the field notes. The corners called for on Porciones 73 and 74 cannot be found. I would like for you to ~~make~~ work on this sketch and if you cannot decide on how this land should be surveyed, kindly let me know if you can send a State surveyor to correct this section No. 340, letting me know his charges. The dimensions shown on the sketch are as found on the ground. Please let me hear from you as soon as convenient, and if there is any charge let me know and I'll remit.

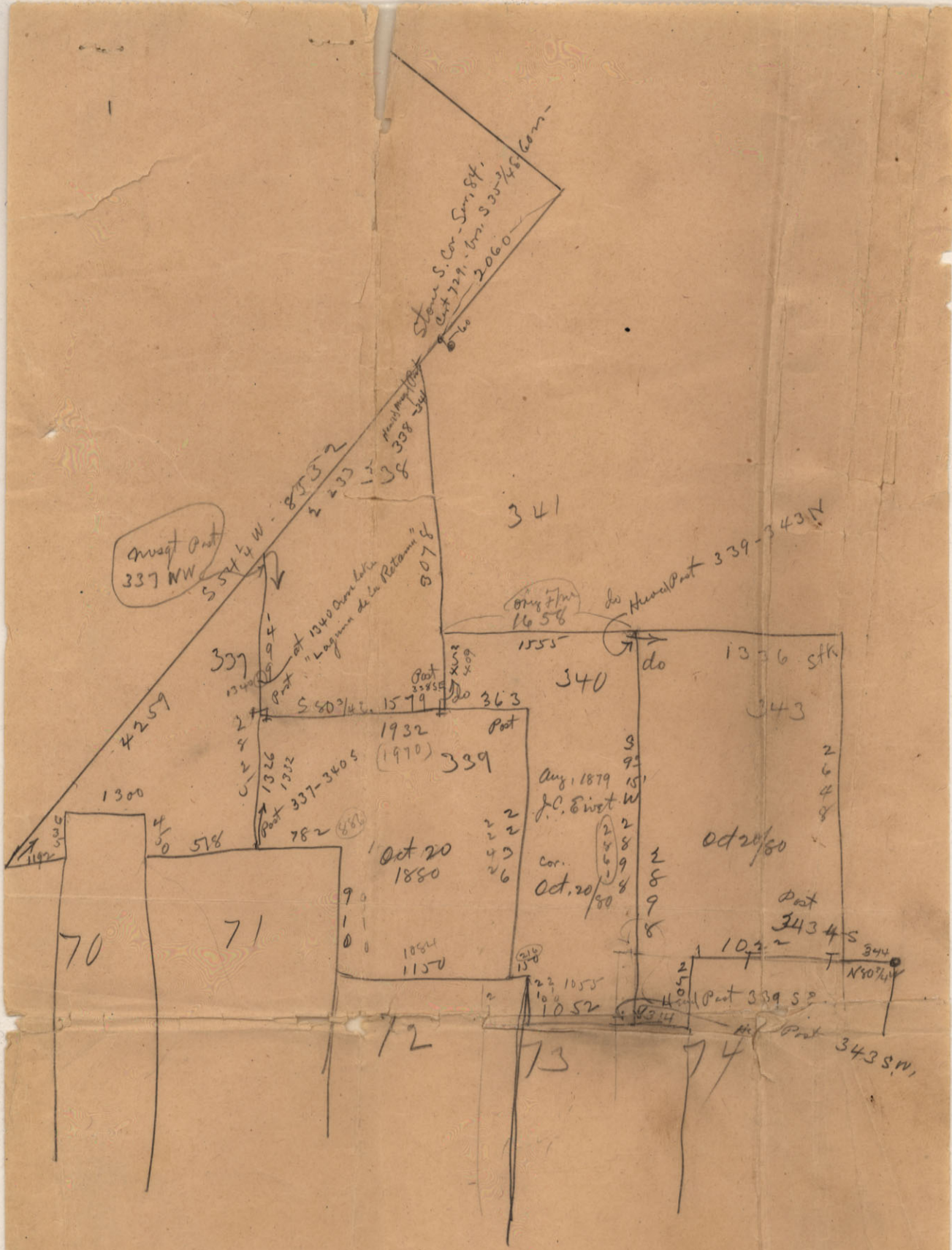
