Dear sir:

I enclose corrected field notes of State Survey No. 962 and patented Surveys Nos. 1035 and 961, together with plat.

In making the survey for the corrected notes beg to submit the following statements as to the original corners found from which I constructed these surveys.

As I was unable to find any corners of Suryeys Nos. 969, 970, 1035 or 1036 there being no marked corners on any of these Surveys, I began at the original N.E. corner of Survey No. 630, found here rk.md. and L.O. now 8" N. 83 E. 2.6 vrs. do now 8" 5251 W. 37.5 vrs. both trees still green with plain marks. Thence N. 83° E. 3800 vrs. set a rk.md. for N.E. corner of Survey No.610. Thence S. 7° E 420 vrs set a rk.md. Thence N. 83° E. 754 vrs. to a cedar 6" in diam. in a rk.md. for S.W. corner of Survey No. 970, marked bearings as follows: a cedar 8" N.73° W. 4 vrs. do 8" S. 20°E 4.7 vrs. From this corner, I located the corners of No. 969 as per plat.

At the N.E. corner of Survey No. 761, I found old rk.md on N.E. side of a mt. from which the pinnacle of a high mt. brs. N.23 E. (see orig. notes of No.762) and a mountain drain half way up a mountain bears N.72 E. (see original notes of Survey No.766) From this corner I set the N.W. and N.E. corners of No. 762.

I found at the original N.E. corner of Survey No. 265, a rk.md. and a L.O. now 12" N.33° E. 13 vrs. a L.O. stump N.11E 18 vrs. 288 vrs. N.65 W. of this corner I found the original N.E. corner of Suryey No. 266 a large rock for corner, a L.O. now 8" N.312 E. 25 vrs. a L.O. now 12" N.36 E. 25.8 both L.O's green with plain marks. From these two corners I ran the South lines of Nos. 961 and 962.

At the S.E. corner of No.1524, found rk.md. and large rock marked B D, N 52 E. 16 vrs. cedar gone.

At N.E. No. 285 found rk.md. cedar now 12" N.12° W. 30 vrs. L.O. now 10" S. 42° W. 116 vrs.
