

Copy of Record made by Wm. H. Millington, Late Surveyor of Aransas County, being a description of the means adopted to locate the North Boundary line of the Lumpster Turner Survey - as follows.

The State of Texas
County of Aransas

On order to establish the north boundary line of the Lumpster Turner Survey of 640 acres situated on the eastern shore of St. Charles Bay in Aransas County Texas the following lines were run, to wit: Beginning at the west corner of a survey of 1280 acres made for James Power assignee of J. A. Sully, from which the west side of a bunch of tracts Class N^o 88th 500 ors, and an island in St. Charles Bay - Cr. N. 69th W (it being the same bearings called for in the original field notes) - thence meandered up the shore of St. Charles Bay, following the courses and distances called for in the original field notes, of the said J. A. Sully survey, also the R. D. Blossman, survey and the E. C. Hoan, and Lumpster Turner surveys, (from point marked B. to point marked E. on accompanying map;) and in running said courses the following discrepancies were discovered, to wit: - On the field notes of R. D. Blossman survey by virtue of Land Scrip No. 93, the call N. 82^o E. 570 ors. calls to cross a bayou, to do this it is necessary to add 120 ors. to the first course of R. D. Blossman Survey made by virtue of Land scrip N^o 115, making said course N. 28¹/₄ E 1782 ors., instead of 1662 ors. and it was further found that the second course in said survey under Land Scrip No. 93, should have been, N. 17^o E. instead of N. 17^o W as called for in original ^{field} notes and I further found, that between the E. Tribble Labor Survey and the Lumpster Turner survey there is a strip of land 603 ors. wide which is subject to Location, and

 2 to purchase, and I further Certify that the mes-
 3 quite post which was erroneously placed for the
 4 O. W. corner of L. D. Blossman Survey understand
 5 Serp N^o. 115, is North 310 pr. and East 352 1/2 cu
 6 from the true corner of said survey, and the red
 7 solid on the accompanying map. A to D truly
 8 shows the line run by E. S. Winsor, as deputy
 9 Surveyor in surveying and locating the Aransas
 10 County School Lands, and other surveys back of
 11 The R. D. Blossman, E. C. Lean, and Sumpter
 12 ~~and others~~ and I further certify that the accompany-
 13 ing map truly shows the position of the surveys
 14 marked thereon as they are on the ground.
