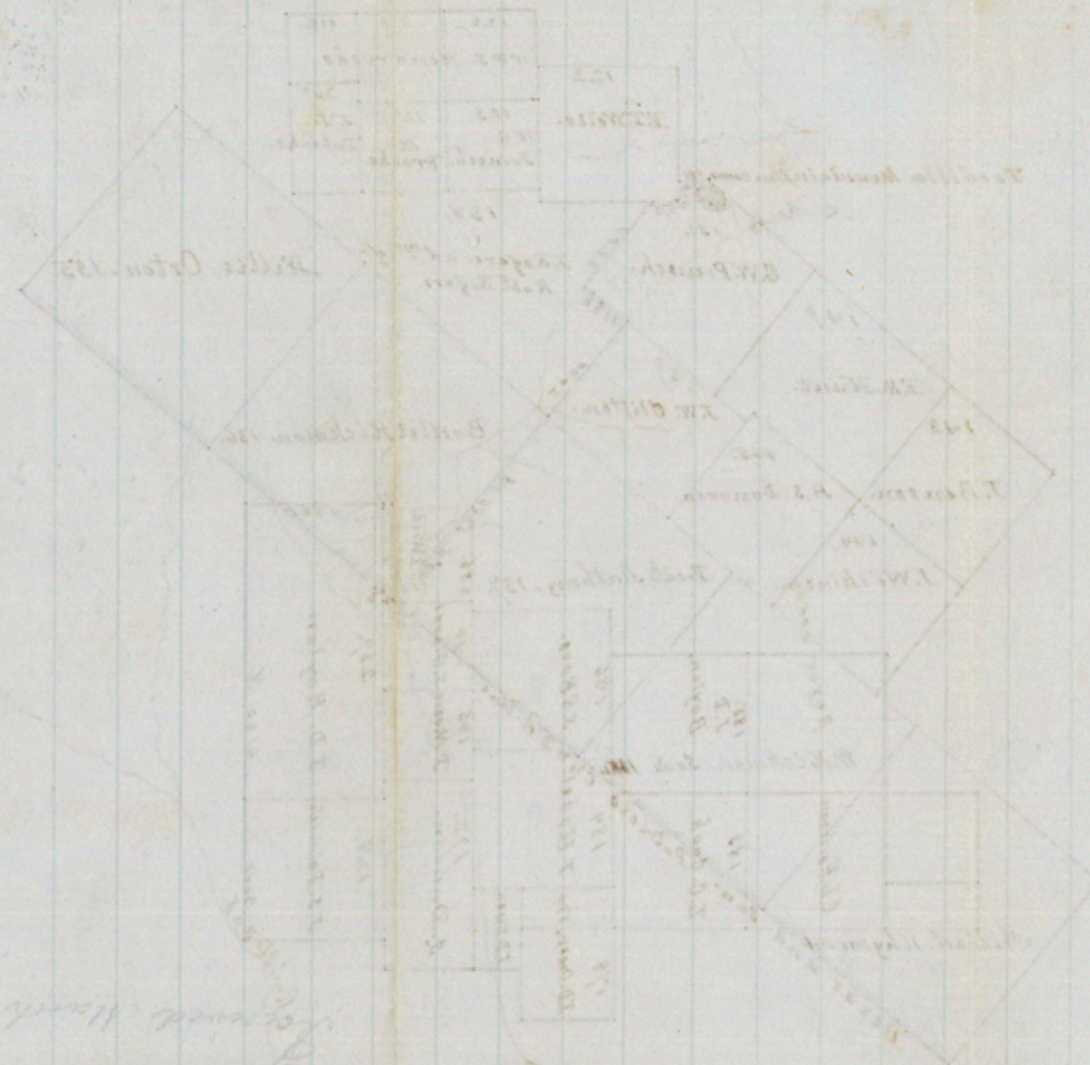

Field Notes of a survey made to ascertain what conflict there is between the surveys on the San Christoval in San Patricio County and the surveys adjoining in Bexar County.

It was commenced at the S.E. cor. of survey No. 128 in San Patricio County made for J. S. Prindexter, from which a L. O. M^{rs} bears N. 24. 00' E. 2.0 N^o and another L. O. M^{rs} T. bears N. 51. 00' E. 24. 00' on the west bank of the San Christoval,

thence run N. at 3000 v^o passed N.E. cor. of said sur.

thence north at 6120 v^o cor. of J. D. Boylan, sur No. 239.

a L. O. M^{rs} Ξ whence a musqt. M^{rs} Ξ bears west, 252. 00'

thence run west at 2889 v^o N.W. cor. of Boylan whence

a musqt. M^{rs} Ξ bears N. 6. 00'
