Reg. at SW cor Capital Sq. ⁵⁹⁴ 593(3), th. South upon the 103 meridians estab. by Geo. H. Clark. at 9110 across Riley wind mill bro N 10.3 3/4 W

July 8 - 1892

at 18000 South edge of sand, at 19305 a mound made by M. Howell connecting with G.S. Sweeney's in New Mexico, at 19335 cross ~~the~~ Kenzie. Mc Kenzie trail, 19423 cross Yellow House road at 19741 and on hill east of Salt Lake built in Jan. 92, at 21385 made 2 pits & a mound. 22400 center of a ravine, at 24622.5 stk, 2 pits & mound on top of low ridge, at 25480, cross ravine at 25557.8 a mound & 2 pits

course W to E, at 9948 a mon. & circ.
trench 8 ft. dia. the N E cor. Mansford
Co. Sch. by 14th at 10394 the
South fence of American Reef Co's
pasture
