REPORT OF A SURVEY MADE FOR, TRAVIS, COLORADO & UPSHUR COUNTIES, by virtue of an agreement between parties in cause No. 1741, Colorado Co. vs. Travis Co., et al, in the District Court of Baylor Co mty, Texas, Special September Term, A.D. 1916.

In determining the location of the lands belonging to the above named counties, in accordance with the agreement, we were governed by the following facts of record and on the ground.

The Southeast corner of Travis County School Lend Survey is determined by a judgment in case of Davis --vs--Travis County, and is located in the north line of T.E. & L. Co. Survey No. 3039, 221 vrs. East of the northwest corner of Same, and the East line of Travis County School Land Survey is a line north from that point.

The East line of the North Upshur County School Land survey is determined by a judgment against said Upshur County and is located 10,000 vrs. east of the Jackson, Howren & Wellace corner. The Morth Boundary line of North Upshur County School Land survey and Colorado County School Land Survey is determined by the position of the South line of the T. & N.O.Ry. Co. Block, the J.K.Kerns, Wm. M. Smith, P.J.Bailey and T ler Tap Ry. Co. surveys. This line we fully identified on the ground placing iron pipes at each original or agreed corner. The west line of Colorado County School Land and South Upshur County School Lands surveys, is determined by the Tyler Tap Ry. Co. Survey and Brooks & Burleson surveys. These surveys are also fully identified by original corners of the Tyler Tap Ry. Co. surveys, the corrected East line of the Brooks & Burleson surveys. G.C. & S.F. Ry. Co. survey No. 22, is not in conflict with Colorado County School Land survey is fixed in a judgment in the case of Lewright vs. Upshur County, as being 452 vrs. south of the Original North line of surveys Nos. 1 and 2 Day Land & Cattle Co.
