

Hon. Commissioner,

I, Citizen
Domenique Wool, a native of Ireland
and a resident of this Town, appear
before you as best provided for
by law and say: That it is five
years since I was introduced into
this colony for the purpose of
pertaining thereto by consent of its
Empresarios and, having selected,
with this understanding, a quarter
league of land contiguous on the
East with M. Clark, on the North
with Media Creek and having its
rear on the Aransasu, I beg and
beseech you to be pleased to order
that it be adjudicated to me in
ownership; and this being the justice
which I implore, I swear etc.

Refugio, December 8, 1834.

sario Power in order that he may
report concerning the conduct, moral
and civil, of the interested party and
whatever else that may be appropriate.

ceding act, adjudicate to him con-
sent having been previously granted
by the Empresario; the quarter league
of pasture land for which he has
applied and which, according to the
measurements made by one of the
appointed surveyors, extends 2019 va-
ras along the Medina Creek, on its
right margin, and its depth on the
lower side being 2898 varas and on
the upper side 3611 varas. It is con-
tiguous on the North with said
Creek, on the West with Citizen Clark,
on the South with Citizen Roache,

and on the East with Citizen Miguel de los Santos. By virtue whereof, exercising my powers and in the name of the supreme authorities of the Mexican Nation and of the State, I put him in possession of said quarter league, he assuming it quietly and peacefully in the act, and being well-informed of the obligations devolving upon him as a colonist, he did not sign in account of not knowing how. I did so with those of my assistance, to which I certify.
