resurvey of the Phoebe Crane League's
Land situated on the Aransas and
Pasta Creeks about 8 miles South
East of the town of Newville.

Beginning
at the S.W. Cor. of a survey made
for J. Coffin at a rock from which
a Live oak 9 in. dia. Mt. 2 x bro.
N 34° W 64 yrs. = Thence N 15 1/4° E. 10,169
yrs. where set a stake in the Prairie
= Thence N 74 1/2° W. 3323 yrs. to a
stake the N.W. Cor. = Thence S 12° W
4300 yrs. striking the Pasta Creek
at three marked trees from which
point the Creek bro. S 20° W. down-
ward (said Mt. 2 trees stand above
and at the junction of a small
ravine with the Pasta) = Thence
down the Pasta with its meanders
as follows - S 20° W 1700 yrs. - S 38° W 400 yrs
(*) Cross from very Creek) S 12° E. 666 yrs. -
S 59° E. 380 yrs. N 32° E. 340 yrs. to a ravine
S 85° E. 306 yrs. S 22° E. 309 yrs. S 2 1/2° W 665
yrs. - S 74° E. 380 yrs. S 31° E. 362 yrs. (at
160 yrs a ravine) S 45° W. 333 yrs.
S 75° W. 499 yrs. S 60° W. 216 yrs. S 35° E. 181
yrs. - S 62° E. 485 yrs. S 45 1/2° E. 237 yrs.
S 8° E. 451 yrs. S 55° E. 262 yrs. S 19° E. 237 yrs.
S 47 1/2° E. 945 yrs. to the place of Be-
gunning - Containing 4698 8/10 acres

of land.

Then by order of
M^{rs} P. Fadden, J. Corrigan and
S. C. Grover Commissioners
appointed by the Commission-
ers Court of Bee County, I
proceeded to divide the same
equally between M^{rs} Jones and
Hatch.
