Dear Sir

I herewith send you Field notes of a survey of a part of the Uranga Grant in Bee County - Through the kindness of a Friend (Judge Pryor Lea of Goliad) the Point at which the East boundary line of said Grant crosses the Blanco Creek, was shown to me, a point from which the line running South crosses said creek, (or rather the channel) three times in a distance of 130 was

Beginning on the N.E. bank of the Blanco Creek opposite the N.E. corner of a Preemption Survey for J. J. Burris - Thence with the traverse of said creek up. S 86 $\frac{1}{2}$  W 312 was - N 48 W 266 was - S 89 W 342 was - N 21 $\frac{1}{2}$  W 330 was at the East bdy of said Uranga - From this point South 130 was to the S.W. bank of Blanco, where Lea & McCampbell's pasture fence crosses the creek - I began to measure on Uranga, as follows viz

South 3900 was to the North bank of Medio Crk  
I find two Hackberries marked with three hacks each  
but do not find the letter H on either - as called  
for in the Field notes, there are scars however which  
may have been the H forty four years ago. I find  
the stump of an old Mesquit on the course called for  
and the only mesquit any where near - The distance  
is not given - There can be no doubt that this is  
the beginning point of the Uranga Grant. From  
this point continued South with the course of  
Creek 600 was leave the bank of Crk 4900 was  
cross a ravine 5000 was find no mound of earth  
and stake as called for - Thence West  
6030 was cross the Yorktown Road 9380 was  
cross the N.E. boundary of Theodor Herencia Sarrey  
10570 was at the Helena Road 186 was south of  
the East corner of J. E. Scotts 640 acre Sarrey  
Finding from this that the Uranga covered nearly  
the whole of the Spencer Morris Sarreys for James  
Taylor and W. M. Jones I continued no further
