a Live Oak mtd. T br. N 33 1/2° W. 72 m.

Thence S 53° W. 5000 m. to a stake.

Thence N 53° E 2500 m. to the beginning.

Thence N 37 W. 5200.00 to a stake from which a S. C. mk'd. v brs. S 49 W. 32.00. another mk'd. v brs. S 68 E. 25.00.

Thence S 53 W. 5000.00 to a stake for the S. W. Cor. of this Sur. from which a S. C. mk'd. x brs. S 63 3/4 W. 21.00.

Thence S 37 E. 5200.00 for the S. W. Cor. of Mary Carroll's Sur.

Thence with said N. W. bdy. line 5000.00 to the beginning.
