Beginning at the S. W. Corner of a

boundary of a Survey in the name of Felia Hart,
575. vrs. West from the N. E. Corner of said Survey.
Set a post for the S. E. corner.

Thence North, with the West boundary
of Timothy Hart's Survey, 8020. vrs. Set post on the
South bank of the Aransas for the N. E. Corner -
from which a Hackberry marked I. brs. S. 60° W.
7. vrs. also an Anagard. Marked I. brs. N 16° W. 9. vrs.
also a Hackberry marked II. brs. N 59° W. 12. vrs.

Thence with the Meanders of the Aransas
N 81° W. 200. vrs. N 50° W. 200. vrs. N 45° W. 500. vrs.
Set post for the S. W. Corner.

Thence South, at 8500. vrs. intersected
the North boundary of a Survey in the name of
Felia Hart. Set a post for the S. W. corner.

Thence East with the North boundary
of said Survey 725. vrs. to the place of beginning.
Containing and later Anagard land, the bal-
ance pasture land.
