

Approximate locations of Post-Offices in Bell County, Texas.

X Bartlett: The town of Bartlett is situated on the W.C.Wilson survey, on both sides of the M.K.&T.Ry. and on the line of Bell & Williamson Counties, and is 1117 varas S.71 E. & about 1750 varas S.19 W. from the S.W.corner of the Theo. Kohlhass 320 acre survey. The County line runs diagonally through the town and intersects the Railroad at a point about 37-1/2 feet N.19 E. from the apparent South line of Clark Street, which is 80 feet wide, and is the business Street of said town.

X Althea is situated on the Davilla grant, and is about 450 varas West of the Bell & Milam County line & about 900 varas North of the Bell & Williamson County line.

X Belfalls is located near the N.E.corner of the E.Davis survey & the N.corner of the M.Hunt 1/4 league, on or near the Bell & Falls County line and is on the Wm.Kibbe, M.Hunt and H.C.Rogerson surveys. about 18 miles from milam co. line

X Belton (the original town tract) is located on the M.F.Connell league, on both sides of Nolands Creek, and the N.W.corner of said original town tract is 4950 varas S.19 W. & 374 varas S.71 E. from the N.W.or upper corner of said Connell league. Nolands Creek empties into the Leon river about 200 vrs. above the upper or N.W.corner of the Margaret Frazier labor.

-X Bland is located on the R.P.Forbes survey, on the East bank of Owl creek, 150 varas above the mouth of Bear Creek, and is 2600 varas N.71 W. & 525 varas S.19 W. from the N.E.or upper corner of said Forbes survey. 3 1/2 miles from Coryell Co line and 8 1/2 miles from

X Brookhaven is on the J.H.Conly 1/3 league, about 800 varas S.71 E. & 400 varas N.19 E from its S.W.corner. 1 mile from Coryell Co line & 18 from Lampasas Co line

X Burgess is on the N.E.bank of Little river, on the Michael Reed league near its S.W.or upper corner. N 36 W about 6 miles from a N.W.cor. Milam Co

X Coppage (recently established) is on the Nancy Chance league, about 300 varas from its East line, and is about 4 miles N.58 E. from Belton. N 45 E. 4 miles from Belton

X Donohoe is on the George Daugherty league about 500 varas N.19 E. & about 500 varas S.71 E. from the S.E.corner of the Daniel McKay 640 acre survey. N 25 W 4 miles from S.S.E. cor Bell Co

X Edgeworth is on that part of the Henry Purdom league which is in conflict with the Antonio DePena grant, but cannot give approximate location. in Milam Co line, and about 4 1/2 miles from Bell Co

X Gindale is on the Jose David Sanches grant, 3000 varas S.20 W. & 1000 varas S.70 E. from its N.W.corner as established by Decree of the District Court of Bell County, which N.W.corner so established is in the S.line of the Woodford league. about four miles North of Milam Co line

X Heidenheimer is on the Maximo Moreno grant on both sides of the G.C. & S.F.Ry. and lies just East of the West line of the David Anderson and the West line of the Thomas Polk. about 8 miles N of Milam Co line

X Holland is situated on both sides of the M. K. & T. Ry. on the J. B. Wills and Reuben Wills surveys and is about half way between the N. E. and N. Q. corner of said J. B. Wills survey. 8 miles W of a N.W.cor. Milam Co

X Killeen is on the San Angelo branch of the G. C. & S. F. RY and is situated on the Alexander Thompson survey and the original town plat includes the North half of said Thompson survey. 2 miles from Coryell Co line

X Kolls is on the F. Madrigal League about 600 varas South of Salado Creek and about 3000 varas N. 19 E. and 1200 varas N. 71 W. from the S. W. corner of said Madrigal League. about 8 miles South of Belton

X Little River is on the Robert Davidson League on the M. K. & T. Ry. and is about 3/4 mile North of the Rail Road bridge across Little River and about 600 varas West of the East line of said League.  
on wrong survey and on wrong side of River on map

X Maxdale is on the T. C. Delano 640 acre survey on the South side of Lampasas River and nearly opposite the S. E. corner of the Harrison Labor.  
on wrong survey on Map. Should be on 8 and not 7. about 5 miles N. of en Bell, Burnet Co Williamson

X Moffatt is on the South line of the Lewis Moore survey right at the N.E. corner of the McCutchen and N. W. corner of the John Weitz surveys.  
S 26°W 9 miles from N. N.E.cor Bell Co.

- X Nolandsville is in the N. E. corner of the J. B. McKeen 520 acre survey and is on the San Angelo branch of the G. C. & S. F. Ry. about 9 miles West of Belton
- X Ocker is on the Joseph H. Clark survey and is situated just South of the North line of said Clark survey, about 200 varas from its N. E. corner. 1300 vrs West of Falls Co line
- X Oenaville is on the W. Hunt 537 acre survey on the East bank of Big Elm Creek and is located about 1/4 mile South of the North line of said Hunt survey. ie Oenavie and on wrong survey on Map, should be about 600 m further North. 3 miles W of Falls Co line
- X Oscar is on the Samuel Humm league about 300 varas N. 71 W. and about 950 varas S. 19 E. from its S. E. corner and is on the North bank of Little Elm Creek. in the Maximo Moreno 11 League grant
- X Pendletonville is on the most Northern of the Wm. Gilmore survey, extending from its West line Eastward and opposite the Middle of the East line of the Luther Smith survey. S 10 E 2 1/2 miles from S.W. cor. McLean Co
- X Prairie Dell is on the James Smith survey about 600 varas S. 71 W. and about 250 varas N. 19 W. from its S. E. corner. about 2 miles N of Williamson Co line
- X Rogers is properly on the Jose David Sanchez Grant but by an Agreement a Judgment was rendered in the District Court of Bell County, Texas, by which 2162 varas in width was cut off the Sanchez and given to the Claimants of the Arocha grant and Rogers is on this strip, so taken off and it is about 1/2 mile South and 1/4 mile East of the N. E. corner of the Goolsby Childers League. on S.C. & S.W. Ry about 1/2 miles from Wilson Co line
- X Salado, the original town, is situated on both sides of Salado Creek in the N. E. corner of the W. H. Heard 1280 acre survey. about 12 miles West of M.H.T. where it crosses Little River
- X Seaton is in the S.E.corner of the Joseph L. Hood league, and near said corner. about 6 miles West of Falls Co line
- X Sparks is on the East side of the M.K. & T.Ry. on the W.C. Sparks league, 2800 vrs. S.19 W. & 100 vrs S.71 E. from its N.W.or upper corner. N 54 W 6 1/2 miles from a NW Cor of miland Co
- X Sparta is on the James Halfpenny survey on the South bank of Cowhouse Creek, just East of the West line of said Halfpenny survey. N 40 W 8 miles from Belton
- X String is on the Mary Stewart survey, S.148. near its North line and about 300 varas West of its N.E.corner. N 77°W 11 miles from E. S.E. Cor. Bell Co.
- X Summers Mill is on the Antonio Manchaca 3 league grant, on the North bank of Salado creek and is about 1100 varas East of its West line. 7 miles S of Belton
- X Temple, the N.W.corner of the original town tract of Temple is 125 varas N.19 E. & 445 varas S.71 E. from the S.E.corner of the G.W.Farris survey and the N.E.corner of the E.Pennington survey, and is on the Maximo Moreno grant.
- X Troy is on the West side of the M.K. & T.Ry.-and is about 600 varas S.71 E. & 400 varas N.19 E. from the S.W.corner of the T.Hughs league. 4 miles from Falls Co + 3 1/2 " McLean Co
- X Vilas is on the Jesse Mumford league, 4800 varas S.19 W. & 200 varas S.71 E. from its N.W.or upper corner. N 11 1/2 E 5 1/2 miles from S. S.E. Cor Bell Co
- X Youngsport is on the F.L.Mudd survey, about 1/2 mile S.19 E. from the S.E.corner of the C.K.Blanchard survey, and is on the North side of Lampasas river, which said river crosses the south line of said Blanchard survey about 100 varas East of the N.E.corner of the E.B.Barton survey. N 57 E 7 1/2 miles from co. Bell, Burnet and Williamson Counties  
on right Survey but about 1/2 mile too far North on Map
