Personally appeared before me, M. Slocum, Clerk of the District Court for said County, Antonio Merchaca, Fernando Gartari, Augustin Barrera and Juan Jose Flores to me well known very aged citizens of said County of Bexar who being by me each duly sworn they and each of them on their oath say that the document on the reverse hereof was made by Don Jose Antonio Sanchez Pol-
 itical Chief of the Jurisdiction of Bexar (Cefe Político de la Jurisdicción de Bexar) in the year 1824, for the regulation of the days of water (Cedulas de agua) corresponding to the twenty five (25) labores of irrigable land belonging to the ancient Mission of San Juan de Capistrano, which, as affiants have been informed by old inhabitants and verily believe was established by the Spanish Government in the year 1746 and has since been continuously in-
 debited, that said document was issued by said Political Chief for the pur-
 pose of officially declaring the proper owners of the 25 labores respectively and defining the rights of water to which they were entitled and was let that
 said document to the Priest (Padre) in charge of said Mission as a liability from
 from personal acquaintance with both said Padre and said Political Chief
 and affiants further say that these twenty five labores together with
 said Mission's Plaza, lot & solar comprised all the land lying between
 the mother ditch (abeyia madre) of said Mission and the San Antonio River
 set testimony whereof I, M. Slocum, Clerk of the District Court
 aforesaid, having fully translated and explained all that is above
 written to each of said affiants, hereto set my signature and
 affix the impress of my official seal at office in the City of
 San Antonio in Bexar this _____ day of _____ AD 1873
