Lieutenant Colonel of the Cavalry of the Royal Armies of His Majesty, Governor of this Province of Texas and Commissioned by the Honorable Commandant General of the Eastern Provinces, Colonel don Ramon de Castro, who act as receiver with attendant witnesses for lack of a notary of which there are none in the terms of the law, having seen the reply given by the Reverend Father President of the Missions, Friar Jose Francisco Lopez, and in order that the provisions of the Act decreed the 11th day of the current month may be carried out, said: Despite having informed the Indians of the Mission of San Antonio Valero through their Father Minister of the superior decree of the Honorable Military Cousellor, the Very Excellent and Honorable Viceroy, Commandant General. let them be called to this Government and being present with said Minister, whom I pray and charge beg to attend Governor Esmeregildo de la Puente and the Indians. Juan de Dios Cortes, Urbano Ynoxosa, Ancelmo Cuevas and Mateo Godines; and they being present said they were deputized by the other Indians of their tribe to acquaint the Honorable Present Governor that they appointed, as they had appointed, their own Governor, Esmerigildo Puente, to attend in the name of all the sons of the Tribe and to hear and

sign the notices and other legal proceedings leading to the fulfillment of the business which has been explained to their Father Minister. In this Act I, said Governor, ordered read to them in clear and understandable words the report of the Honorable Count of Sierragorda which follows in this file, the opinion of the Military Counsellor, the decree of agreement of the Very Excellent and Honorable Viceroy. Count of Revilla Gigedo. and Commanding General, along with the act decreed by me; and after being well informed that the lands of the Mission are to be distributed to the old time residents of Adaes Presidio, those attached to it or servants of said Mission, and to each of the Indians who have belonged to it, at the rate of four Almudes of planting, setting aside the portion needed to cultivate it, sowing it with fruits suitable to pay what is owed to said Mission whenever the case arises that its delivery to the Ordinary is ordered; and desiring that said Indians have the benefit and advantage of the land worked according to the knowledge they may have of it, it was proposed to them that they chose in which of the two labors they wished to have the land assigned to them by the Superiority distributed to them and said Governor answered, as did the others who were present, that they wished the Valero labor distributed to them and where there should remain remain enough ground to plant sufficient to pay from its fruits the debts to the Mission similar to the delivery to the Ordinary, and later they would decide to plant a community field for the benefit of themselves and the Adaes residents.

This they answered and said Esmeregildo signed with his Father Minister, Friar Jose Francisco Lopez; I, said Governor, signed it with attendant witnesses with whom I act as aforesaid, I certify. M. Munoz Friar FL Francisco Lopez By me and as attorney_in_fact of the other Indians of the Missi

In the Town of San Fernando and Presidio of San Antonio de Bexar on the 7th day of December of 1793, I, don Manuel Munoz, Lieutenant Colonel of the Royal Armies, Military and Political Governor by his Majesty of this Province of Texas and subdelegate in the two <u>causes</u> of the Treasury and War, having received this superior order of the Honorable Commandant General of the Internal Provinces, Field Marshal, don Pedro de Nava: I said that it be added to the file of which it speaks, and place it in the Archives of this Government in order to given the testimonios requested by the parties of the Adaesinos and other residents comprised in the file, thus I resolved and signed as aforesaid.
