Md. for the Common corner to Surveys 29, 30, 19 and 20, Block 214, Wh. Straddlebug Mtn. Brs. N. 8-40' W. North high Pt. 9 Pt. Mesa Brs. N. 74-23' E. High point Aqua Frio Brs. S. 14-20' E. Mont. on Mtn. Brs. S. 13-30' E.

Thence, South at 950.4 Vrs. set Stk. and Rk. Md. on South slope of ridge at 1536.8 Vrs. point on top of Bluff, at 1900.8 Vrs. set Stk. and Rk. Md. for the common corner to Surveys 29, 30, 31 and 32, Block 214,

Thence, South at 950.0 Vrs. set flag and Rk. Md. on edge of wash, Whence, High pt. Aqua Frio Brs. S. 17-58' E. Bluff West end Aqua Frio Brs. S. 0-45' E. & on in all 1900.4 Vrs. set Rk. Md. on shale hill, Whence High Pt. Aqua Frio Brs. S. 19-37' E. Mtn. peak Brs. S. 51-41' W. South edge of Bluff Brs. S. 79-38' W. for the common corner to Surveys 31 and 32, Block 214, and 5 and 6, Block 215,

Thence, Back to Rk. Md. N.W.5, Block. 215, T.& St.L.Ry.Co. and go East 1900.8 Vrs. Point in flat looked around for mound, (none) Bld. Rk.Md. for the common corner to Surveys 32 and 33 Block 214, and 4 and 5, Block 215, T.& St. L.Ry.Co. from Whence; High point Aqua Frio Brs. S.9-02'E. Bluff West end Aqua Frio Brs. S.11-24'W. Mtn. peak Brs. S.78-55'W. Mtn. Pk. Brs. S.58-40'E.

N.62-35'E. Bluff West side of Aqua Frio Brs. ~~S.10-48~~ S.1-05'E Mtn. peak Brs. N.60-55'W.


