

And it appearing to the court that interlocutory judgments have been heretofore rendered and entered herein as follows:

(1) On May 16, 1962, an agreed judgment as between the plaintiffs, Philip R. Overton and M. C. Overton, Jr., and defendant Mamie Hubert Ryan (also known as Mary Hubert Ryan) with respect to the ownership of a certain portion of the land described in plaintiffs' petition;

(2) On July 6, 1965, a default judgment in favor of plaintiffs and against certain defendants, being Jesse Adams et al, who failed to appear, awarding to plaintiffs a recovery of the title and possession of the land described in plaintiffs' petition as against the said defendants, Jesse Adams et al;

(3) On December 2, 1965, a second default judgment in favor of plaintiffs and against certain defendants, being Magdalene Knapp Aigler et al, who failed to appear, awarding to plaintiffs a recovery of the title and possession of the land described in plaintiffs' petition as against the said defendants Magdalene Knapp Aigler et al;

(4) On October 21, 1966, another interlocutory judgment on separate trial in favor of plaintiffs and against the defendants cited by publication, being defendants F. A. Adair et al, certain minor defendants, being Suzanne Angst et al, who were personally served with citation, and still other disclaiming defendants, being Allan G. Aigler, executor of the estate of Frank A. Knapp, deceased, et al, both said minor defendants and defendants cited by publication being duly represented by a court-appointed attorney, said interlocutory

judgment awarding to plaintiffs a recovery of the title and possession of the land described in plaintiffs' petition as against the three several classes of defendants just named, and further declaring that said plaintiffs have an indefeasible fee simple title to said property.

And the court now finds that each of the foregoing four interlocutory judgments was and now is correct, and same are now final.

And all parties so appearing having announced ready for trial on the merits, and it appearing to the court that all parties to this suit were properly before the court, and that the court has jurisdiction of this suit; and no jury having been demanded, the court thereupon directed said cause to proceed to trial.

The pleading and evidence, as well as the argument of counsel, having been heard and duly considered by the court, the court on the 6th day of February, 1967, finds that the facts and law are with the plaintiffs, and that plaintiffs should have and recover of and from the defendants/the lands and premises in controversy, ^{except as is hereinafter otherwise adjudicated,} and that all facts necessary and proper sustaining the following judgment of this court have been duly pleaded and proved.
