WITNESSETH: That whereas we the aforementioned parties are the owners of certain tracts of land located in Block S, Block 3, A.B. & M. Block Y-2, Block None and Block 5, B.& B. in Carson County, Texas and

WHEREAS, it is the desire of the parties hereto to settle and make certain the boundary lines of their respective tracts of land.
