Field notes of a survey of 70<sup>10</sup>/<sub>100</sub> acres of made for G. F. Mitchell of Anahuac, Texas. By virtue of his oil and gas prospect application # 32, filed with the Surveyor of Chambers County on the 5<sup>th</sup> day of November 1916 at 9:0 O'clock P. M. Under section 4, Chapter 173 act approved April 9<sup>th</sup> 1913 and as amended.

Being located in Chambers County Texas about 12 miles S. W. of the County seat and about 1 mile above the mouth of Cedar Bayou on the East side thereof said survey covering the entire surface of submerged land covered by a body of water known as Ijams Lake and more fully described as follows.

Beginning at a stake on the South point of a neck of land and the north bank of the opening between Cedar Bayou and Ijams Lake thence following the Meander of the above mentioned Ijams Lake at the tide mark as follows
