In locating vacancy bounded on the North by the John Preston Survey; on the East by the Samuel C. Beldon survey and the John Reding survey; On the South by the George Rathbon survey; and on the West by Section No. 7, T. & N.O.R.R.Co. Survey. I began at the Southwest corner of the James H. King survey, this survey was made on Sept. 3rd, 1854, the South West corner of said survey calls for a post oak marked X brs. N. 55 W. 38 vrs. The Old Stump of the Witness Tree is still on the ground but badly decayed. The corner of this Survey is in the N. line of State Highway No. 5, and 6 vrs. E. of the W. line of a public road leading North, where I erected a pile of stone in the North Base Line of the Samuel Beldon Survey. Running from this poing West with the N: line of the Samuel Beldon and the S. line of Section of Sec. No. 1, T. & N.O.R.R.Co. at 812 vrs. I relocated the L. corner of said Sec. The distance on the ground from the S.W. corner of Sec. No. 1, T.& N.O. R.R.CO. to the S.W. corner of the Able Lewis survey is 7091 vrs., whereas the call distance on the original Field Nites is 7043 vrs. there is an excess of 48 vrs. in this line which is held by Sec. No. 8 T.& N.O.R.R.CO. surv. which I believe is confirmed by the Court Verdict Plaintiff, State of Texas, Verses Worsham & Prater, et al.

I did not think that it would be necessary to survey the W. base line of the Able Lewis sur., as I have made several surveys along that line, and I am satisfied with the distance North and South. The distance from the N.W. corner of the Able Lewis sur. to the S.E. corner of the Jas. B. Owensby sur. is 2832 vrs. on the ground. The original pile of stones together with iron pipes driven in the ground on a rocky nole prairie covers the original callings. These corner calls for a witness tree, but the State Highway, and the R.I. & T.R.R.Co. Rightway covers that portion of the ground.

The distance on the Ground from the N.E. corner of the Jas. B. Owensby sur. to the S.W. corner of Sec. No. 29, which is also the S.E. corner of Sec. No. 30, H.& T.C.R.R.Co. survs: is 680 vrs. making the total distance from the S.W. corner of Sec. No. 1, T.& N.O.R.R.Co. survs. to the S.W. corner of the Able Lewis sur. 7091 vrs. There is a vacancy bounded on the North by the Day Land & Cattle Co. sur. No. 1535, on the West by the Marion County School Land sur. on the South by the Wm. Campbell sur. of 160 acres and on the East by the John B. Culwell sur.

I find that according to the callings of the original Field Notes of both W.B.Worsham survs., show that there is an excess in each one of them survs., as surveyed on the ground recognizing the callings of the original Field Notes.

There is also an excess in Sects. No. 30- 31- 32- 33- 25 and 36 made for the H.& T.C.R.R.Co. survs., for which Survs. corrected Field Notes have been filed.

I assume that the State has recognized the excess in those Sects. by issueing a patent for the North Half of Sec. No. 34, to A.J. Weldon, calling for 340-4/10 acres of land, and also issueing a patent for the South one half of said Sec. No. 34 to G.H. Turner, which also calls for 340-4/10 acres. The callings on those Patents from the N.E. corner to the S.E. corner of each one of those survs. call for 1244 vrs., making the total distance for the entire Section 2488 vrs., whereas the distance on the ground is 2488 vrs., and the call distance for those Sections as given in the original Field Notes call for 2337 vrs.
