

Thence West 1900 vrs to stone mound in valley - from which a Mesq. 4" brs N. 61° W. 8½ vrs - another 4" brs S. 42½° E. 6 vrs. (About 300 or 350 vrs East reach valley which is about 800 vrs wide.)

Monday April 7. 1879

Began at stone mound at N.E. corner of U^o 1 - Mesq. brs S. 89½° W. 146 vrs - another brs N. 88° W. 140 vrs -

Thence South 1900 vrs to a stone mound.

Thence South - at 1480 vrs crossed branch - course N.E. - 1900 vrs to a stone mound - from which a Mesq. 3" brs S. 54½° W. 28 vrs - another 3" brs S. 3° W. 49 vrs.

Thence South - at 600 vrs - 630 vrs and 680 vrs crossed branch - course N.E. - at 1900 vrs stone mound - Mt Marqy brs S. 53° W.

Thence South - at 1820 vrs crossed branch - course N.E. - 1900 vrs to a stone mound - Mesq. brs S. 85° W. 53 vrs - another brs S. 73½° W. 31 vrs - Mt Marqy brs S. 84¾° W.

Thence South - at 1140 vrs branch - 1300 vrs -

Thence West - at 165 vrs crossed branch - 1900 vrs -

Thence North - at 200 vrs cross road from Fort Chadbourne to Fort Coucho - 1200 vrs.

Tuesday April 8. 1879 -

Thence North 1900 vrs to a stake - from which Mt Marqy brs S. 23° W.

Thence West - at 1520 vrs crossed branch - 1900 vrs to a stake from which a Mesq. 4" brs S. 80° E. 11 vrs - Mt Marqy brs S. 24½° E.

Thence West 1900 vrs to rock mound on point of mountain - Cedar 12" brs S. 73° W. 20 vrs.

Thence North - at 1420 vrs crossed branch - 1900 vrs to stone mound on side of mountain.

Thence North 1900 vrs to a stone mound.

Thence West 1900 vrs to a stone mound - Warrens Peak brs S. 5° E.

Thence South 1900 vrs to a small stone mound - Warrens Peak brs S. 9° E.

Thence West 1900 vrs to a stake from which a Mesq. 2" brs S. 72° W. 16 vrs.

Thence South 1900 vrs to a stake from which a Mesq. 4" brs N. 19° W. 7 vrs - another 4" brs S. 89½° W. 14 vrs - Warrens Peak brs S. 73½° E.

Wednesday April 9. 1879.

Began at point last described on preceding page-

Thence West - at 745 vrs crossed Branch - 1900 vrs to a stone mound on point of mountain - Cedar 3" Brs N. 60° W. 10 vrs - another 3" Brs N. 8° E. 11½ vrs.

Thence North - crossed Branch - 1900 vrs to a stake from which a Mesq. 2½" Brs S. 79½° W. 12 vrs - another 3" Brs N. 75° W. 13 vrs - Nipple Peak Brs S. 36° W.

Thence South 300 vrs to a stone mound.

Thence West - at 220 vrs crossed Branch - at 720 vrs crossed Cove Creek - (Lip Oak Creek) - 1900 vrs to stake - Mesq. 2" Brs S. 163° W. 20 vrs - Nipple Peak Brs S. 9° E.

Thence South - at 740 vrs crossed Cove Creek - 1900 vrs to stone mound at foot of Nipple Peak on West side.

Thence West - at 810 vrs crossed Branch - at 960 vrs crossed Branch - at 1520 vrs crossed Cove Creek - 1900 vrs to a stone mound - Mesq. Brs N. 23° W. 8 vrs.

Thence North 1900 vrs to a stake - Nipple Peak Brs S. 49¼° E.

Thence North 1900 vrs to a stake - Mesq. 1½" Brs N. 48° W. 12 vrs

Thence West 1900 vrs to a stone mound.

Thence South 1900 vrs to a stone mound - Mesq. 3" Brs S. 45° E. 7 vrs - another 4" Brs N. 54½° E. 18 vrs.

Thence South 1900 vrs to a stone mound - Nipple Peak Brs East.
