Sent the field notes to your Office, where they were acted upon and Patents thereon issued to C C F Blanchard during the present year.

I made these surveys, taking the junction of the Colorado & Concho Rivers as my starting or beginning point, because it was the beginning place of the surveys located on the Colorado River, and all surveys lying between the Colorado River Surveys and the Concho River Surveys, and the

Course no course or bearing trees have been found on the Colorado River, either by myself or the Surveyors of Runnels County or anyone else. The junction of the two Rivers being called for in the Field notes of H. Sankoff being No 77, and being the only course on the Colorado River which can in any manner be identified, there being no doubt that the junction of the Rivers is exactly where it ever ~~was~~ where the Sankoff survey was located, the course it is laid on either <sup>side</sup> with any large Pecan trees.

The junction of these Rivers, on the old Fisher & Miller map, on the map of Concho County, and on working sketches made by your office from one on the 30th Jan 1884, is laid down as a course, or bearing point of the Sankoff well says on the Colorado River - Laying the junction of the two Rivers as the only course on the
