I, Frank F. Friend, County Surveyor of Crockett
County, do hereby certify
County, do hereby certify that on the 9th day of November,

1907, with chain carriers duly qualified, I carefully measured the following
Connecting Line in the South West portion of Crockett County, Texas:

Beginning at the N.E. corner of Sur. # 150 and the N.W. corner of
Sur. # 170, Block O, G. H. & S. A. Ry. Co., a R.M. marked "N.W. 170", on
ridge at head of small canon, from which a cedar 5" in diameter bears
N 86 1/2° E 203 varas, ledge of flat rocks marked (X) bears S 83° W 4.4 Va.

Thence S 89° 52' W 1900 varas to a R.M. marked "N.W. 180" for the
N.W. corner of Sur. # 190, Block O, G.H. & S. A. Ry. Co., from which a cedar
5" in diameter bears S 60 1/2° W 67 varas; rock (E) bears S 76 1/4° E 9.6 Va.

Thence S 0° 08' E 1900 varas to a R.M. marked N.W. 141 for the
S.W. corner of Sur. # 180, Block O, G.H. & S.A. Ry. Co., on West side near
head of canon, from which a cedar 8" in diameter bears N 88 3/4° E 201 varas;
rock marked (X) bears N 43 3/4° E 5 varas.

Thence W 1950.6 varas to a point in the East line of Sur. # 46
Block A, G. C. Ry. Co., from which a rock mound bears S 1253.5 varas made
for the S.W. corner of said Sur. # 46, from which a rock on ledge marked (X)
bears N 40° E 19 varas; (T) on rock ledge bears N 88° W 7.6 varas.

Thence North, at 646.5 varas passed a rock mound, the N.E. corner
of said Sur. # 46 and S.E. corner of Sur. # 45, same Block, from which a ce-
dar clamp bears S 43 1/2° E 205.6 varas; cedar clamp bears S 63 3/4° E
205.6 varas, at 2548.5 varas in all to a R.M., the N.E. corner of Sur. # 45,
same Block, from which a cedar clamp bears N 63° W 55.6 varas, cedar clamp
bears S 70° W 88.8 varas.

All the bearings above mentioned were identified on the
ground.

This Connecting Line is indicated in red ink on the enclosed
plat of Corrected Surveys of the Texas Mexican Railroad Company.
