

Fieldnotes of a connecting line in Crckett County
run from Kuechler's Lake or Elbow Lake on the East
Fork of Devils river at the intersection of the East and North
prong or Coucho and Lano forks of Devils river to South
East corner of Ferdinand Fertoch 320 acres survey at Willow
Spring on main Devils river.

Tuesday October 27th 1885.

Beginning at a small pile of rocks on the bank of
river in the Elbow  known as Kuechler's Lake
or Elbow Lake at the intersection of East and Northprong,
or Coucho & Lano forks of East Fork of Devils river, the
above point was identified and pointed out by Mr.
Jacob Kuechler the original locator of Survey No. 3
Rusk Transportation Co. ^{Cert. No. 106.} and distant 950 ors N45° E from its
S.W. corner, upon which Kuechler's lake is situated.

Thence N89° W crossing fork of Devils river, at 1140 ors foot of
hill, continuing same course across the hills at 2350 ors
enter valley, at 3300 ors cross small dry branch, course South,
7640 ors cross a dry Creek, course South, at 11145 ors. cross a
dry Creek, at 11540 ors. a point on side of hill.

Thence S13½° W 320 ors. to a point.

Thence S86° W up a valley at 480 ors. cross dry Creek, continuing
up the valley and across divide at 5500 ors. to a point
in a skew, at its head.

Thence N34¼° W down the branch at 1760 ors. a point in
valley course S. W.

Thence S86° W down valley at 2000 ors. cross Creek, at 2260 ors.
same Cr. a point. went into camp on main Devils
river about ¼ mile distant, no water.

Wednesday October 28th /85.

Beginning at a point end of yesterday's work

Thence $S86^{\circ}W$ at 430 vrs. cross main Devils river, course
 S.W. at 500 vrs. cross Dove Creek road at 580 vrs.
 a point from which a lone Mesquite tree brs.
 $N75\frac{1}{2}^{\circ}W$ 144 vrs. —

Thence $N13\frac{1}{4}^{\circ}W$ up Devils river valley at 380 vrs. cross
 river, at 420 vrs. cross Dove Cr. road, at 555 vrs. cross
 small Creek, course West, at 1800 vrs. ^{river bed} to 2016 vrs up bed
 of river to point.

Thence $S61^{\circ}E$ 12 vrs. to a dwarf Willow tree on side of
 bluff.

Thence $N62\frac{1}{4}^{\circ}W$ in bed of river 80 vrs. to point.

Thence $N25\frac{3}{4}^{\circ}W$ up the river at 1160 vrs cross river at
 1180 vrs a point on East bank, large valley on West
 side of river.

Thence $N24\frac{1}{4}^{\circ}E$ up the river on its East bank at
 1980 vrs. on side of bluff opposite mouth of a large
 Creek coming in from the West, continuing same
 course 4180 vrs. a point on the East bank of river.

Thence $N54\frac{3}{4}^{\circ}E$ 400 vrs. point in valley.

Thence $N26^{\circ}E$ up the valley 3388 vrs. to a point in bed
 of river.

Thence $S61\frac{1}{4}^{\circ}E$ 29 vrs. to a large Willow tree at Willow
 Spring now dry, situated on the Ed. J. Blackey
 survey.

Thence $S65^{\circ}W$ down the river bed 200 vrs. a point.

Thence $S1\frac{1}{4}^{\circ}E$ 512 vrs. to the S.E. corner of Survey
 No. 1 in the name of Ferd Fertsch, an old dead Mesquite
 stump 5" in dia. mkd. O. lying down, a small
 pebble mound $1\frac{1}{2}$ vrs distant, from which a L.O.
 8" in dia. mkd. $\frac{7}{8}$ brs. $N65^{\circ}E$ 184 vrs. another L.O.
 about 7" in dia. mkd. $\frac{7}{8}$ brs. $N50^{\circ}E$ 183 vrs.

both bearing trees were identified by Mr. Jacob
Kuechler the original locator as the same
that he had marked for the S. E. corner of F.
Fentsch 320 acres survey.

E. corner of the Ferd. Fentch survey near Willow Spring on main Devils river and pointed out to said party the point of intersection of said forks marked by a small rock mound ~~and~~ made N 45° E 9500' from the S. W. corner of survey ~~the~~ approved by me as Deputy Surveyor Texas District No. 10th 1877 for Rank Transportation Co. and also showed the S. E. corner of the Ferd. Fentch survey, identified by the bearing trees marked by me and still alive.
