Dear Mr. Walker:

Enclosed herewith find field notes of surveys in  
Crockett County, conforming to sketch also enclosed.

This sketch is based upon the statement made by  
Charles E. Davidson, County Judge and Civil Engineer,  
made April 30, 1919, and found in Land Office SF file  
No. 12125. In the third line on page two of this  
statement is evidently a typographical error, in that  
the distance in said statement of 1701 varas should  
read 1711 varas.

The sketch will show that between the northwest corner  
of section 28 in Block "F" and the row of corners south  
from the northeast corner of Block "M" there is found  
on the ground considerable excess. Owing to the fact  
that the owners of the two west tiers of Block "F"  
have accepted and are measuring 1900 varas west of the  
northwest corner of 28 for their distance the sketch  
was drawn to conform to this measurement, but between  
Block "F" and Block "M" the sketch shows the excess  
distributed. Consequently I have prepared the corrected  
field notes of section 6, Block "J" upon which Mr. Child-  
ress wishes to secure patents. Kindly refer to your  
letter of December 21, 1933, addressed to Davidson and  
Smith, Ozona, Texas, paragraph two.

The writer discussed at length the matter contained in  
this letter personally with the Land Commissioner; con-  
sequently, it is requested this correspondence be referred  
to him before final action on same.
