Parrish, County Judge of Crosby Courty, Texas, an official certificate certifying that upon the offieial map of Crosby County the geographical center is a point within the limits of section No. 2, land certificate No. 305, block No. 1, I. & G. N. RY. Co., seven hundred and sixty-five (765) varas S.54<sup>3</sup>/<sub>4</sub> E from the north-west corner of said section No. 2:

That the official map of Grosby County used in determinnig the geographical center herein referred to is dated Nov. 1900, and since that date has been continuously in use in this office as the official map of said county: That the northern boundary line shown on said map corresponds with the field notes of the southernboundary line of Floyd County surveyed by Ira Millington, state surveyor, on the 23rd to 31st days of October 1891, filed in this office Nov. 9, 1891: That the eastern boundary line shown on said map corresponds with the field notes of the western boundary line of Dickens County surveyed by W. R. Norwood, Dept. Dist. Surveyor, and J.J.Hale, County Surveyor D. Co. T:, in February and March 1892, filed in this office March 25, 1892: That the southern boundary line shown on said map is a projection west 30 miles from the southwestern corner of Dickens County as fixed on the map by field notes of the survey made by said W. R. Norwood and J. J. Hale: That the western boundary line shown on said map is a projection north from the western terminus of the southern boundary line to its intersection with the Southern line of Floyd County:
