## PERSONAL

Mr. C. S. Blucher, General Land Office, Austin, Texas.

Dear Mr. Blucher:

I have obtained from Mr. R. J. Owen the corrected field notes for the Morgan claims in Culberson County, Texas. Mr. Owen is of the opinion that the law requires that the corrected field notes be filed in the land office "without delay." Mr. Morgan naturally does not wish to do anything that might jeopardize the legality of his claims, even though the added burden of doing assessment work this year would be the penalty for hurrying up the filing of these corrected field notes. Consequently I am today forwarding, by registered mail, to the land office the full set of field notes, and am also returning the maps.

I am aware that this places everything in the public file, but I do not see any way to avoid it and at the same time fully comply with the legal requirements. On the other hand it is almost certain that in checking over the field notes you will find a few errors which will have to be rectified. A considerable amount of time will no doubt be required to check over all of these corrected field notes, especially as I understand that you are badly pressed with other work and considerable additional time would no doubt be required to obtain the corrections for the errors which may be found. In this way the final awards for the claims might possibly be deferred until after October 1. I assume that you would not award the claims singly or even in groups, but that you would withhold all awards until all of the field notes had been properly filed and corrected. I would much prefer to have the claims all awarded at the same time if you can do this.
