S U R V E Y R E P O R T

This report covers the survey of the south half and the northeast quarter of Section 18, Block 7-T, Texas and New Orleans Railroad Company Survey (T. & N.O. RR. Co.), Dallam County, Texas, situated about 18 miles N. 54° E., of Dalhart Texas. This survey for patent was ordered by Robert C. Ferguson, Attorney, in Dalhart, on behalf of Mr. Elton L. Terrell. Mr. Ferguson requested, by a letter dated January 6, 1993, a reply and an approximate cost for survey services. A letter, dated January 13, 1993, was sent to Mr. Ferguson containing brief information of past surveying in the area concerned, with the survey service fee. The survey order was confirmed, via telephone, by Mr. Ferguson on January 21, 1993.

Section 18 was surveyed on August 10, 1990, for preparation of field notes and a patent of the northwest quarter of said Section 18. The records and information obtained for the 1990 survey were used for this survey. Field work was done on February 23, 1993, where-in all the monuments of Section 18 set and/or found with the 1990 survey were recovered and checked for proper position, according to the said 1990 survey.

This report, accompanied with the recorded field notes and respective plat (Exhibit "A"), consists of the following:

- 2.) Exhibit "B"; a General Land Office working sketch prepared July 11, 1990.
- 3.) Exhibit "C"; copy of a portion of U.S.G.S. Quadrangle "Wilco NE, Tex. 1965", showing the area of the survey.
- 4.) Exhibit "D"; copy of recorded field notes of the northwest quarter of Section 18, with the plat and survey report (photographs exempted) prepared for the 1990 survey.

As mentioned previously, the monuments for Section 18, as established in the 1990 survey, were recovered and found to be in proper position. There-by, the south half and the northeast quarter of Section 18 was established according to the 1990 survey. A 1 inch iron pipe stamped "S.E. N.E. 18" was set at the midpoint of the east line of Section 18 for the east quarter corner. Witness corners were also set at the southeast section corner and the east quarter corner as indicated in the recorded field notes and plats "Exhibit "A". The south half of Section 18 contains 319.81 acres, more or less, and the northeast quarter of said Section 18 contains 159.90 acres, more or less. The north 50 feet of the northeast quarter of Section 18 is occupied as right-of-way for F. M. Highway No. 3213. This right-of-way strip of land is removed from this survey at the request of Mr. C. B. Thomson, Director of the Surveying Division of the General Land Office, Austin, Texas. Removal of the right-of-way leaves 156.87 acres, more or less, in the northeast quarter. The total area of this survey, being the south half and the northeast quarter, save and except the north 50 feet thereof, contains 476.68 acres, more or less.




