I have run a line northward from the southwest corner of Section No. 132, Block M, as now marked by Mr. Sylvan Sanders as restored by him to be the corner as marked by Collard and Estes, this line to strike the north line of Block M, as marked by this line to strike the north line of Block M, as marked by Surveyor Twichell and projected one mile westward from the 4 inch casing set by Mr. Twichell for the northwest corner of Section No. 117, Block M.

This line I ran happens to be exactly 15 miles long and I have used this line to determine how much of League No. 283 is in conflict with Block M.

I have determined the location of League No. 283 by the reamining subdivision corners I have found and connected with to show the amount of the conflict. The labores of this League were marked by one inch galvanized pipes. I have only found three of these pipes, one at the southeast corner of Labor NO. 21 one at its southwest corner and one at the southwest corner of the Labor west of it.

"I have given courses in this letter and sketch accompanying it, compared to a Meridian through U. S. C. & G Survey Station "Ceder Lake" which is situated in the section each of No. 139, Block M, so they can be companyed with Sanders' courses which are compared to the same meridan. I have computed the conflict between Block M and the Laborgs of League No. 203, as determined by this line and the above described pipes marking the location of the laborgs.

The part of Labor No. 21, League No. 283, is described as BEGINNING at a one inch galvanized pipe, the original southeast corner of Labor No. 21, League No. 283; Thence S. 75 51 * 30°W. 560.6 varas to a 2 inch galvanized pipe at the intersection of the west line of Block M with the south line of Labor No. 21; Thence N. 14 43* 50°W. with the west line of Block M, 1000 varas to the north line of said Labor No. 21; Thence N. 75° 51° 30° E. 570.8 varas to the northeast corner of Labor No. 21;
