Report of lines run in accordance with instructions from the Gen Land office as per Blue sketch print of 1860 B. Public school lands in Jackson and Crosby Counties - making each sur. East and West 2056 m long, and the 3 western lines of 1860 1. North West of 179, also 2050 m - East to determine the location of 2 surveys made for J. H. Airheart as in relation to said Blue sketch.

Began at the N.E. cor of sec 87 Bet 2. N 49 W in Crosby, Co. The corner work of Bet 2, by George Speller a stone pile - thence East at 950 m cross West line of a sur made for J. H. Airheart at 2056 m as stake for N.E. cor 21, 38-23, S 1/4 24 and N 1/4 20 - 1860 B. as per sketch hereto attached. at 2878 m the S 1/4 cor of the C. C. Wheeler square 160 acre Pat Preemption at 4112 m a stake in the N line J. H. Airheart sur. at 4590 m a stone cor - The N.E. of J. H. Airheart 160 acre Pat sur. and N 1/4 cor J. H. Newton and heretofore claimed as the S 1/4 cor of sec 216 Bet 1. The fence of the Espula Land and cattle G. is run on a line North from this point and from which point all the Pro surveys lying North as shown by the attached sketches were located and marked on the grounds, and by said Blue sketch and distance from Speller line of Bet 2, are in conflict with Bet 1. some 378 m - The Pat sur. East & South of the N 1/4 cor J. H. Newton are located from what is known as the Red rock cor. and called S 1/4 sec 179 Bet 1. a line run from E line Bet 2. Speller work allowing 2050 m East for 3 lines of sections leaves them also in conflict with Bet one as indicated by the attached sketch -  
though they call to begin on Bet 1.
