Dear Sir,

As required by your instructions of Nov last, I have run a connecting line from the N.E. Cor of the Wm Cain sur of land in King Co - to the N.W. Cor of sec 91. J.R. Co in Wickens Co. and hereby doth certify that I started at the S.E. Cor of the Wm Cain, it being the only known Cor of said survey, and ran North, Variation 10.00 E 5098 m to a point for the N.E. Cor. I then turned my course West to make a connection with the N.W. Cor of the same Legarus block of Land, and ran 9500 m a point - from which the N.W. Cor. of sec 7. Sam Legarus. brs S-100 m and West 352 m. I find the old Cor. with both cotton wood bearing trees in place. though one tree is down, I then ran north 3800 and ran the same distance north and East of the N.W. Cor sec 9. the N.W. bearing tree still in the ground, thence West 1900 m North 1900 m. West 5700 m for the S.W. Cor 94. J.R. Co. and thence north 7600 m to the N.W. Cor sec 91. J.R. Co. at which point I find to be 384 m East and ~~1400~~ 1400 m South of the file Cor where Capt Stoney places the S.W. Cor of sec 2. N.W. Co. - I then ran E- 3800 m. and north 511 m - and connected with the S.W. Cor of the John Leven sur No 13. = I note from Capt Stoney's Report of Nov 28th 05. - That he calls your attention to a line run by Sam Chalk - which line I have marked on the attached sketch in red.

dotted lines - I took a different course
1st to connect with some tied down corners
of the Lazarus Block. and 2nd to get off
the line run by him - The west line of
the Goals by pre sur is the matador fence.
he reports his run to come out some 107 or
East of it. There is only a few rods difference
between us. though I ran a little further north
than he does. as he does not reach the 4th fence
by 175^m. = I once - several years ago - ran
a line with the King Co Surveyor. from the Wm
Cain due North to the N.E. cor of 148. to what
is known as the Buffalo heads Cor. Course
and distance from the N.E. Cor of the Wm Cain
will not reach that Cor. which fact I believe
I once before reported to you. I will ~~not~~ make
any further corrections on the strip of land
laying north of the I.R. Block. and filed on
by Parker Kitchen & others until I hear from
you in regard to the connecting lines run as
required. by you. and herein reported
accompanied by sketch hereto attached - as I
don't care to put these people to expense. until
we have something tangible to work on.
