Dear Sir;-

The inclosed corrected fieldnotes are based upon a survey made by me the first part of this November.

I ran a connecting line from a well established corner at the S.W. corner of Survey 11, Block E to a rock mound at the S.W. corner of Survey 12, Block C-8. The Surveys to the north of the rock mound at the S.W. corner of survey 11, both to the west and to the east for five miles each way are all based on this corner, so, in the absence of any original corner along this line, I began here because it is the line established by agreement and practice by the property owners both north and south. The corner at the S.W. corner of Survey 12, Block C-8 is well defined and has been accepted for years by the owners to the East, but by reason of the topography of the country to the west, all fences in that direction just hit or miss.

I also ran a connecting line from the S.E. corner of Survey 24, Block C-8, where the County has graded a road North and West 1 mile, to an old stone mound recognized as the N.W. corner of Survey 27, Block C-3.

Using the line from the S.W. corner of Survey 11, Block E. to the S.W. corner of Survey 12, Block C-8 as a base line north and south, and using the line from the S.E. corner of Survey 24, Block C-8 to the N.W. corner of Survey 27, Block C-3 as a base line East and West, I constructed the Surveys covered by the fieldnotes hereto attached.

This country is all ranch lands, too rough for farming, and the owners thereof should be urged to survey all their lands and acquire the excess acreage.
