

Corrected field notes of a Connecting  
line from the N E cor of sur N<sup>o</sup> 33  
Blk 11 - S. Chas<sup>l</sup> P. Co - to the N W cor  
of sur N<sup>o</sup> 25 - S. W. 7 + P. P. Co at Kickapoo  
Springs - Beginning at a Stone mark in the  
valley of Indian Creek - the N E cor of sur  
N<sup>o</sup> 33 - made for Geo H. Tolson. From  
which Black Jack 8 in dia - brs S 12° E  
& 100 v - Black Jack 10 in dia brs N 20° E - 160 v,  
thence S 70° W 13 miles, thence S 70° W to 200 v,  
Rk mark at the mouth of five mile Creek  
on West Success - this Rk mark having been  
made in 1841 - as a point in Connecting  
line - thence South 400 v - thence S 30° W  
to 100 v, thence S 40° W 1600 v. thence S 17° E  
1300 v, thence S 7° E - 2400 v - thence S 22° E  
410 v, to the mark the N W cor of sur  
N<sup>o</sup> 25 from which an Elm tree 12 in dia  
brs S 37° W 16 1/2 v, an Elm tree 14 in dia  
brs S 41° W 17 1/2 v, last named tree being  
cut down - but mark showing on the stump  
On comparing the above with connecting  
line - returned in 1841 - it will be seen  
that a sandstone course was erroneously  
returned between the mouth of five mile  
Creek & Kickapoo Springs -
