The District Court in & for the County
of Falls,

In Pursuance of an order made
at the last, or full term of said Court AD,
1869, directing the undersigned Surveyors to
proceed and run, or make any surveys
if any the land claimed by J. C. Pool Plaintiff
and G. Jones Defendant, Conflicts, & also the
land claimed by Rhoda Huelkins Et al,
Plaintiffs Conflicts, if any with the land
claimed by, & in ~~possession~~ possession of J. C.
Pool Defendant, said lands, situated
in Falls County, on the East Margin of
the Brazos River.

In accordance with said order,
We the undersigned Surveyors met on
the 11th day of November AD 1869, at what is
known as the Falls of the Brazos, on the
East Margin of said Stream & all the Parties
having been notified, and being present
either by ourselves or attorneys, we ascertained
by the Calls of a D^o La Serda grant, and
the field notes of the Jose M. Sanchez
survey, together with a full & complete
examination of lines & natural marks

The precise location of the southerly line of the said La Serda grant, it being the northern line of the said Sanchez Survey, and for more particular description, reference is hereby made to our accompanying Plat which is made a part of this report.

We then proceeded to ascertain the boundaries of the Gregorio Basques Grant, and finding that the Surveyor of Austin and William's Colony located the same on what is known as Austin & Williams reserve line, after searching, we found marks corresponding in age & course, in Post oak timber near the North end of what is known as Hog Island, after tracing said marks about fifteen miles & finding the line to ~~be~~ run N 71 E, running from the Brazos River & judging from the age of the marks & course of the line together with facts, that after it passed the said Basques N.E. River Corner it ran across, & without respect to all the known surveys of the Section where it passed, & there being no corners made on it. We were entirely satisfied, that we were on said reserve line. We then ran the northern boundary of the Basques to the

to the East Bank of the Brazos River and found the following results, that all the land claimed by said J. B. Pool, is included within the boundary of the said Basques & the said Sanchez surveys as set forth in our accompanying Plat of said survey -


