To, the Honorable J.T. Robinson, Commissioner of the General Land Office, Austin, Texas.

I beg lieve to report the survey made in connection with W.W.Hunnicutt County surveyor of Falls County and R.S.Hunnicutt inregard to the location of the John Gafford Two Labors situated on the North line of the J.G.W. Pierson league in Falls County Texas. on the 3rd. day of June 1921, with R.S. Hunnicutt, Commenced in the North line of the J.G.W. Pierson league at a point that is now recognized as the Southwest corner of the William Roberts Labor and the S.E. corner of the William Hampton survey, we found no bearings such as called for in the field notes of the Roberts and Hampton surveys. Thence S 59:3/4 degrees west at 1045 varas make examination for the South-

west corner of 'Labor No.7, but found nothing to correspond with the calls in the field notes of Labor No.7.

The filed notes I found among the papers and documents of J.G.W.Pierson

The filed notes I found among the papers and documents of J.G.W.Pierson who was the presiding or general surveyor of the Nashville or Robertson Col-ony and are hereto attached marked exhibit "A" here the fine charge for the Continued with the line of the Pierson league 2045 varas , made search for a line running N 30 W. but found nothing, and at 2506 varas is where the public road leaves the line of the Pierson league, entered the timber , find some marks in my judgement is old enough for the line of the Pierson league 3173 varas is the S.W. corner of the William Hampton survey, which I identified by two hearing trees which places the corner on the South of the fence line

by two bearing trees which places the corner on the South of the fence line at this point, at 3208 varas are two Post Oak treest standing South of the fence line and very nearly in line with the Hampton corner, one about 16 inches in diameter, bears N 80 W/ 3.3/10 varas and another bears S 18 E. 5.4/10 varas about 20 inches in diameter corresponding very nearly with the bearing trees called for at the Southeast corner of the John Gafford Two Labors, after fixing the corner from said trees as above stated ,take a course S 58.1/2 W find some marked trees, some of them in appearance is old enough for the line of the Pierson league, continued and at 3727 varas the east bank of Piersons

creek which is a caving bank, at about 3750 varas the east bank of piersons varas the line changes its course S 59.3/4 W. At 4611 varas a small branch at 4816 varas leave the timber, at 5492 varas the S.W. Corner of the John Littlewood survey, and Southeast corner of the George Webster survey, the bearing trees are not standing now, but have seen them many times while standing,

Then with R.S.Hunnicutt go to the waters edge on the west of the Brazos river.Thence S 59.3/4 W. at 728 varas, the old west bank of the river, at 2637 varas the channell of Piersons Creek, 2660 varas old west bak, at 2746 varas Mulberry branch, just above is confluence with Piersons Creek, 3221 varas the recognized zorner of Roberts and Hamptons survey, June 7th. and 8th. 1821, Then with W.W. and R.S. Hunnicutt, commenced at

varas the recognized zorner of Roberts and Hamptons Call, commenced at June 7th. and 8th.1821, Then with W.W. and R.S.Hunnicutt, commenced at the corners of the Roberts and Hampton surveys as recognized, ran N 30 W.
950 varas Mulberry branch, at 1000 varas in the bottom, examined for the N.E. corner of Labor No.7. and S.E. corner of Labor No.8, but find nothing to indicate the corner or the bearing trees, continued N 30 W. 2000 varas. Thence S 60 W. 475 varas mulberry branch, about 30 varas South of the line 663 varas come to the branch.

Then go to the Two Post Oak Trees in the line of the Pierson league, that I take for the corner of the John Gafford Two Labors. Then ran N 30 W. at about 1000 varas is a glade of prairie with scattering

Post Oak treess.

Col. Churchill Jones who was the owner of the John Gafford Two Labors, the William Hampton , and the John Littlewood surveys sold to F.G.Pool two tracts of land , one tract of 29.96/100 acres on the John Gafford two Labors, and 87 acres on the west of said John Gafford survey, the field notes of said survey I hereto attach marked Exhibit "B", the field notes I find among the papers of John H.Pierson who was living with his father J.G.W.Pierson at the Town of Viesca in Robertsons Colony in 1835, and fequently accompanied surveyor in making surveys, and he was County surveyor of Falls County about the time he made the survey for Jones and Pool, about 1884 or 1885 Col. A.E.Watson owned a large tract of land covering the South part of the Hampton, Littlewood Webster and Leonard surveys, except the Pool 87 acres tract, I was emplowed by him the said Watson to survey his land for the purpose of fencing said land and I found one of the bearing trees called for in the field notes of the Pool survey, fixing the corner of the F.G.Pool tract, which calls for the S.W corner of the John Gafford two Labors, it is about 2000 varas from the two Post Oak trees, I take for the S.E.corner of said Gafford two Labors, and about 270 Col. Churchill Jones who was the owner of the John Gafford Two Labors, the

Oak trees, I take for the S.E. corner of said Gafford two Labors, and about 270 varas from the corner of the Littlewood and Websters surveys.
