Recently I have had occasion to run a traverse from the original Northwest corner of Section 141, Block 2, H.&G.N. R.R. Co. Survey, Abstract #105, Crosby County, Texas, to the present occupied North line of Section 32, patented to P. D. Adams, file number 51529, Floyd County, Texas and found the actual measured distance on the ground North to be 37,563.19 varas, whereas the total call distance is 37,750 varas, leaving a shortage on the ground of 186.81 varas between the two points.
