do hereby certify that this map, correctly represents  
a series of measurements and connections in Fort Bend  
County made by me, at the request of Rolt W. Ely

That it is to begin from an Iron Post in the North cor-  
ner of the A. Dorch League known to me, to be cor-  
rectly placed there by me from actual measurements from  
the Bernard River along the N.W. line of the same  
to N. Cor in S.W. 1/4 of Sect. 20 survey Thirtieth Range,  
Third Range N.E. 5507 acres to said Iron post.

From this Iron post in N. Cor of A. Dorch I measured  
North west 26484, acres - placing a cedar post at  
each 1900 ft as indicated on this map, crossing  
as indicated roads & streams - Then I measured  
West from the said cedar post to the P.D. & H. survey  
at the S.E. 1/4 line of E. Powell, which is the point in said  
line where the N.W. 1/4 line of the H. & C. RR surveys into  
Sect. the E. Powell League, and at 15444 ft was 78  
S 45° W from the S.W. Cor of H. Scott League - an Iron  
post - and correct by measurement and intersections

Truly, I measured from the N. Cor of the R. Hodge, an Iron post  
correct by me from actual measurements from the old marked  
Corner (R.H.) & intersections of N.W. line still carrying the old  
marks in the Bernard timber - and going S 45° E into sec  
1/4 line from the N.E. of A. Dorch to S.E. 1/4 line of Sec 20 E  
2443 ft. Thence N.W. along that line 5595 ft - Thence  
N 45° E 8460 ft to a post in the corner of the  
A. J. Dennis, and C. Stewart surveys - S 45° W from where  
the marked line leaves the creek 5300 ft.

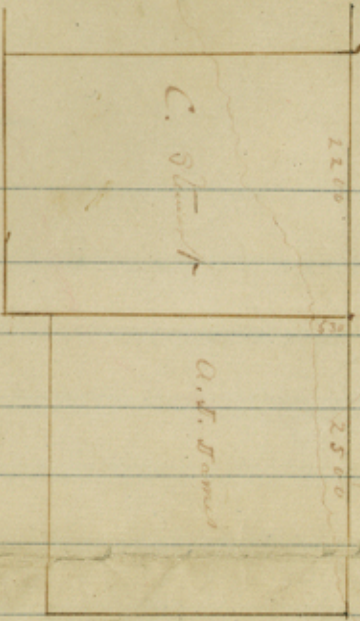
