it ought to be N. W. Cor. of Rixon's Survey - how-
ever they know at the Office what it ought to
be from the balance of the Calls of the F. N.
& will please instruct me accordingly -
The Field Notes I presume will have to be
returned so as to be corrected & to correct
the Record also - The ^{map} Government dues
will have to be paid on the Survey in the
name of A. J. Blick & W. F. Gray & also the
N. O. Meritt, but I know this last will
not be reached for some time yet -
By making your application as soon as you
go in you know will give you preference
