3. That certain oil, gas and mineral lease, dated May 5, 1976, between the Standard Dredging Corporation, as lessor, and Buttes Resources Company, as lessee, covering, among other things, its undivided three-fourths (3/4) interest in that same 200 acre tract, more or less, in Offatt's Bayou, in Galveston County, Texas, and covering a 120 acre tract, more or less, in Offatt's Bayou, in Galveston County, Texas, and retaining a one-sixth (1/6) royalty interest, and whose assignees as lessors are defendant Clay M. Hunt, individually and as legal owner of an unrecorded interest on behalf of defendants William C. Richardson and S. D. Windham, Inc., and defendant Robert L. Ruehman, Trustee, and which is on file in the records of the Galveston County Clerk in the Oil, Gas and Mineral Lease Book 2681 at pages 441-449.

Windham, Inc., have and recover from the escrow account No. 05790 on deposit at the U.S. National Bank of Galveston, Texas, the sum of eight-ninths (8/9) or 88.89% of all production royalties that have been paid into the account by plaintiff Mitchell Energy Corporation, and all interest that has accrued on that amount in the account. This sum shall be made payable by the U.S. National Bank of Galveston, Texas, less any applicable penalties, immediately upon receipt of a certified copy of this final judgment, to Ernest V. Rountree, as attorney and authorized agent on behalf of these defendants. It is further

ORDERED that plaintiff Mitchell Energy Corporation have and recover from the escrow account No. 05790 on deposit at the U.S. National Bank of Galveston, Texas, the remaining sum of one-ninth (1/9) or 11.11% of all production royalties that have been paid into the account by plaintiff Mitchell Energy Corporation, and all interest that has accrued on this amount in the account. This sum shall be made payable

by the U.S. National Bank of Galveston, Texas to Mitchell Energy Corporation immediately upon receipt of a certified copy of this final judgment. It is further

It is further

ORDERED that defendants Robert George Bisbey, Trustee, Virginia B. Ball, Maco Stewart, III, Wells Stewart, Clay M. Hunt, William C. Richardson, Robert L. Reuhman, Trustee, and S. D. Windham, Inc., be and they are hereby restrained and enjoined from making any further claims, or from instituting or prosecuting any action whatsoever against plaintiffs Mitchell Energy Corporation, Mitchell Energy Offshore Corporation, and Florida Gas Exploration Company, for or on
