Survey of three hundred and twenty acres of land made for Richard Stiles by virtue of Certificate No.171, issued by the Board of Land Commrs. of Shelby County for six hundred and forty acres of land situated about 4 miles north of the Sabine River and about 3 miles west of the Jonesborough Road, Survey No.253.

Beginning at the N.W. Corner of No.252, from which a Black Oak 20 inches D. bears S.11 $\frac{1}{2}$ ^o E. dist.3-4/10 vrs., A pine 24 inches D. bears S. 61^o W., dist.13 vrs;

Thence West 476 vrs. set stake from which an Elm 10 I.D. bears N. 22^o E., dist.7-2/10 vrs., an Elm 6 inches D. bears S.72^o W., dist. 7 vrs.

Thence North 684 vrs. Creek 4 vrs. C. S.W., 950 vrs. S.W. Corner No.176, from which a Black Oak 24 inches D. bears N.37^o E., dist. 2 vrs., a Pine 30 inches D. bears N. 17 $\frac{1}{2}$ W. dist.20 vrs;

Thence East with the line of No.176, 1900 vrs. S. E. corner of No.176, from which a Pine 10 inches D. bears S. 23^o E., dist.1-4/10 vrs., a Pine 10 inches D. bears N. 46^o W., dist. 19-6/10 vrs.

Thence South with the League Line marked W. C. 950 vrs.N.E. corner of No.252, from which a Black Oak 14 inches D. bears S. 38 $\frac{1}{2}$ ^o W., dist. 18-6/10 vrs; a Black Oak 12 inches D. bears N. 38^o W., dist.10 vrs;

Thence West with the line of No.252, 1424 vrs., place of beginning, 320 acres of land, Oak, Hickory and Pine timber. Surveyed 28th. day of January,1846.
