

Statement with regard to Survey Surveys made for
the Houston & Texas Central Railway Company

Survey No. 13

This Survey as corrected May 21st 1874, is re-
ported by the General Land Office, "to be in conflict
with a patented Survey in the name of D. Floyd,
and that the calls for the Beatty Surveys seem
to be wrong" ——— All the maps
from the Genl. Land Office represent the N.W. corner of D.
Floyd & the N.E. corner of P. McDonough as identical
but not finding the bearings of P. McDonough to answer
to those of D. Floyd, & finding no line from
thence East, I measured from the S.W. corner of
D. Floyd North to the N.E. corner of P. McDon-
ough, ^{at} that time found it to chain 1700 vs.,
and finding a deficit in D. Floyd's West line
and a marked line continuing North, I extended
the line the the length of 1900 vs (or 200 vs more)
& after diligent search ^{finding my corner} I established one.

By subsequent measurements on the E.P. Mi-
sick, P. McDonough & Jas Shelton, I am lead
to believe that it is about 1765 vs from the
S.W. corner of D. Floyd to the N.E. corner of P. Mc-
Donough, & if so the West line of D. Floyd is 1965
vs & there cannot possibly be any conflict between
No. 13 & it, unless it is much larger than rep-
resented. The maps represent the North line
of D. Floyd & the North line of P. McDonough as

 forming one & the same straight line, but to avoid
 a conflict I extend the D. Floyd North 200 vs.
 I cannot ascertain how the conflict supposed
 to exist, is arrived at by the Gen. Land
 Office. The calls for J. N. &
 W. B. Beatty Surveys are proper & have been veri-
 fied

No. 14

This Survey is reported as follows — "Does not
 close, error in Southings 43 vs — Westings 175"
 Making out a table of Latitudes & Departures ac-
 cording to the recorded field notes, I find an
 error of only 1 v or in Northings & 2 va-
 ras in Westings; but upon making a recal-
 culation of Area, I found a small deficit
 & have corrected this Survey and herewith
 return corrected field notes.

No. 15

Is reported to be in conflict with two preempt
 coins in the name of Jos & M. L. McCombs

There appears to be a conflict as stated, ac-
 cording to the plat accompanying field notes of
 M. L. McCombs' Survey & its connection ^{as there reported} with W. K.
 Estill's Survey. This disagreement was explained
 in a statement sent up some months ago

The error grew out of an erroneous repre-
 sentation of the connection of M. L. McCombs'
 Survey with W. K. Estill's; said connection
 having been made by running two lines
 from the N. E. Corner of W. K. Estill, the course of one of
 which was misread from the field book & occasioned
 the error. The positions of said Surveys

are correctly represented on the Sketch accompanying this Statement & on the plat connected with filed notes of Survey No. 14. There is no conflict of this Survey with No. 8 as is supposed

No. 16

This Survey as corrected is reported to conflict with Nos. 19 & 20. According to the filed notes of Nos 16 & 21 as first transmitted and to connected sketch of all the work ^{the distance} from the N.E. corner of No. 16 to the ~~reimtrant~~ N.E. corner of No. 21, as is stated as 2083 vs, & the length of South line of No. 16 & North line of No. 21 ~~is~~ stated as 1829.

A subsequent survey made May 21st 1874 found that the former line should be 2153 vs, and the latter 1860 vs. This will explain the apparent conflict of 31 vs with Nos 19 & 20, & would make an apparent conflict of 70 vs between Nos 16 & 21, but not 178 vs as reported. An explanation of this ~~is~~ made when transmitting corrected filed notes of No. 16 & 21 — There is no conflict on the ground

No. 19

New filed notes have been made out & are herewith returned

No. 21

In this Survey the Genl. Land Office represents the error in Northing 47 vs, Easting 84 vs.

By preparing a table of Latitudes & Departures, I find the error in Northing 1 over & in Westing 9 15 vs. The error in Westing is chiefly caused by the rough, steep ground over which the 3^d course has to be measured, as it tra

verses, a high rugged hill. If this course be diminished about 11 vs as it might probably be, the Survey will lack but little of balancing

No. 20

The recent measurements of Nos 23, 24, & 26 disclose some errors in No. 20, but as the Survey may have been patented, I have thought it best not to correct until I receive instructions from the Commissioners

Nos 24 & 30

The 3^d course in No. 24 or the 11th course in No. 30, should be 488 vs instead of 458 vs as reported in the field notes of those Surveys first sent up. In making a re-survey of No. 30 the error was discovered

When the field notes of No. 30 were prepared the first time, the lines bordering on E. Smith & J. O. Blair, were adopted from field notes of those Surveys & some previous ^{work} on J. O. Blair. The measurements given in corrected field notes of No. 30, herewith sent, are from actual measurements

I will add that when these surveys were made for the H & T. C. R. R. Co, for the sake of dispatch, which the Company were urging, I employed two other Surveys to assist me. And although great precautions were taken to compare compasses & chains, some unavoidable errors have occurred from the use of three different compasses & chains, & from the employment of several sets of chain-carriers

Some errors are also due to the brusqueness of portions of the country & the diurnal changes to which the magnetic needle is subject.

The cosmopolitan's great experience in practical surveying will enable him to appreciate the force of these remarks.
