I then connected this corner with the stone corner to No. 2. E. L. R. R. R. Co. being same corner called for by the Wheeler county School Land. The bearing trees from this stone are as follows, A triple Hackberry two of which are marked bears S. 43 E. 110 vs. another Hby. bears S. 26 1/2 E. 171 vs. a faked Hby. br. S. 25 E. 102 vs. The Va. as shown from this stone to the bearing trees is 10.45 E.

I found this corner N. 533 vs. and East 1424 vs. of the N. E. corner of Sec. 269. Bl. "H." W. + N. W. R. R. Co.

In running this connecting line I found the Va. to be 9.15 E.

I then went back to the N. E. cor. sec. 27. Bl. "H." W. + N. W. R. R. Co. and ran S. 13300 vs. the common corner of sections 40. 41. 37. continuing S. at 15200 vs. the S. E. cor. #40. + S. W. cor. #41. same survey. from which corner Wanders creek bears S. 620 vs. - I then went back to S. W. corner of #41 as ^{found} established by me and ran S. 36 1/4 E. ^{458 vs} to a stake just west of a ravine put in as S. W. cor. of said #41, by W. F. Westmanna, (late sur. of Wilbourn co) From this stake I ran South to 170 vs. to Wanders creek. from this stake a west line would run north of Sanders creek, as it makes the bend. I then went to S. W. corner of sec. 41. as located by me and ran East 2850 vs. to N. E. corner of #2. E. L. + R. R. R. Co. thence S. 1600 vs. to a stake on N. bank of Wanders creek, continuing to 1634 vs. to head of creek the stake is just west of a ravine, a tall cotton wood bears S. 17 E. 34 vs. marked =. I then went to the two pecan trees called for on Wanders cr. and on S. b. line of sec. 53. Bl. 10 H. + J. C. R. R. Co. which are 1235 vs. N. 72 E. of its S. W. corner.
