which a Cow oak 14 in diameter N 4° E 6<sup>1</sup>/<sub>2</sub> Vs.

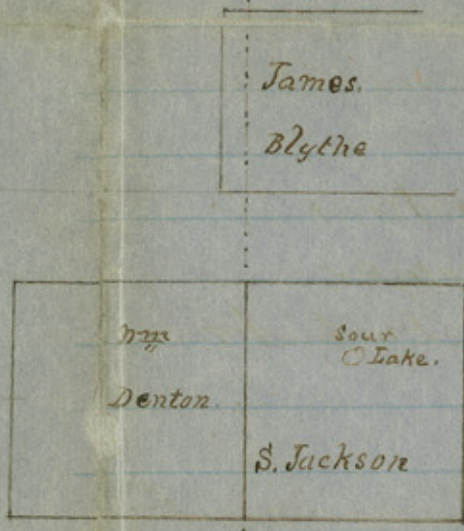
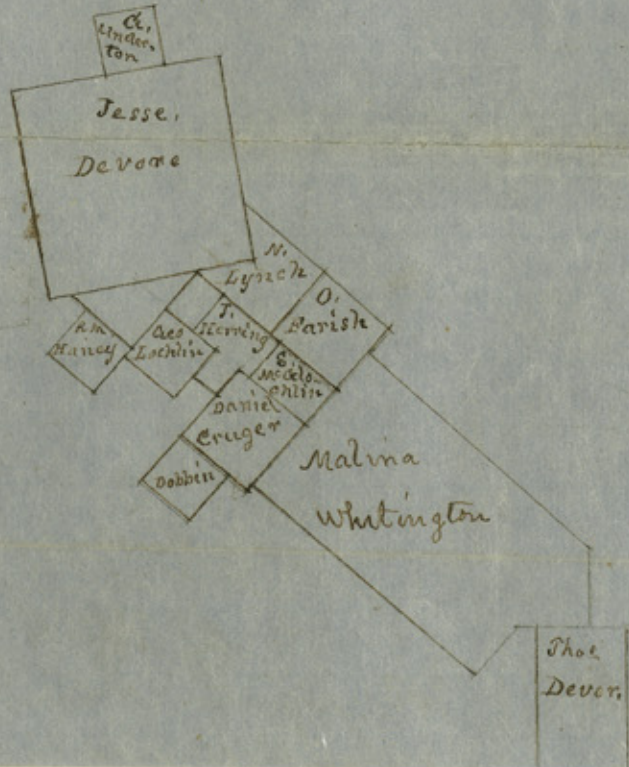
