I, William Ward, former surveyor of Hardin County, do hereby certify that a certificate made by me in the latter part of the year, 1860, or the first of the year 1861, designating the position of the Mariah Ximines league of land, was an error caused by the ~~presentation~~ representation of Mr. Nobles, who I had given a special deputation to hunt that league. I have since found by actual survey made by me that he connected it with the Bartlett Eaves survey, instead of the J. Eaves survey, which is called for in the ~~survey~~ field notes of the Ximines league.

I therefore wish that certificate cancelled, as I have no knowledge where the Mariah Ximines league of land lies.
