Field Notes of Surveys made to locate Secs. 1 & 2 G. C. & S. F. Ry., Co. Certificate 5071 and Section 1&2 Washington County R.R.CO. Cert. 118.

The circumstances are peculiar. The San Jacinto Rice Company has reduced its Nine or Ten Thousand Acres to one vast Field, except fencing for roads and its boundary line, and in doing so has removed all the artificial objects ~~and~~ planted for the corners except as indicated in the Field Notes. Mr. Bradburn therefore directed the plan of the survey made. BEGINNING at the S. W. Corner of the Blodgood in the center of the County Road, N. $9^{\circ} 40'$ W. 12.8 Varas and S. $80 \frac{1}{4}^{\circ}$ W. from the old fence Corner, ~~where~~ a line S. $80 \frac{1}{4}^{\circ}$ W 7.74 Varas from the point where the old fence line East of Cedar Bayou intersects the East Bank of the Bayou and 1500 Varas distant, along an old hacked line. Thence S. $80^{\circ} 45'$ W. with the old fence line from 12.8 Varas South at the beginning and 45.3 Varas South of the line at 1975 Varas where the old fence line ends, ~~passing~~ South 6.8 Varas of a painted stake at 139.7 Varas, passing South 11.5 Varas of a Post at 1573 Varas, at 2727 Varas a stake the S. W. Corner of the Ritchie and at 2737 Varas ~~amount~~ 3.6 Varas North and a fence line corner marking the N. W. Corner of the Barrow at 3997.4 Varas in all a stake and a fence corner marking the N. W. corner of the Gillette.
