about 15 Miles from Houston, Tex.

Beginning at a point on Mud Lake near the Mouth of Middle Bayou in the Timber at End of Fence.

Thence North 64 o West with fence, leave timber at 205 varas, enter timber again at 275 varas, at 390 varas Corner of Wire fence running North 34 o 30 ' East, at 928 varas small timber, at 2127.5 varas Corner of fence running South 26 o West, at 2530 varas corner of fence running South 26 o West; these two fence enclose a rice field, enter timber again at Corner of said field, at 2572.6 varas South bank of Horse Pen Bayou, at 3785 varas West Bank of said Bayou, at 5375 varas the N. W. Cornerof Sarah Deal Survey at 7110 varas small creek, at 7680 varas North Bank of Horse Pen Bayou, at 7905 varas South Bank of same Bayou, at 10155 varas Corner of Fence, at 10182 varas an Iron Pipe the S. W. Cornerof this Survey, This Line is well na rked through the timber.
