Dear Sir:--

In making the surveys of the Public School Lands in El Paso county, from June to December, 1900, the following connecting lines were run, and corners identified.

No. 7, Block No. 74, the Station House at Fort Hancock bears N. 46 35' W.; thence S. at 100 vrs. old road, at 300 vrs. small arroya, at 400 vrs. road, at 2400 vrs. G. H. & S. A. Beginning at said Flag Staff; thence E. 5276 vrs. to a pile of rocks; thence S. 8202 vrs. to a mound of earth and stone on W. side of arroya, from which the old stage stand at mouth of Quitman Draw, or canyon, bears due N. 118 vrs.; thence E. 9500 vrs. to a pile of rocks on W. slope of a mountain; thence S. 9500 vrs. to a pile of rocks in mountains; thence S. 1276 vrs.; thence W. 445 vrs. to the lower river corner of survey No. 36, Block No. 4, T. & P.
